Please be advised that Harvey E. Yates Company hereby makes application for administrative approval of an unorthodox location, pursuant to Rule 104-F, for its Travis State Com #1 well located 1780 feet from the South line and 2080 feet from the West line of Section 13, Township 18 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. The Travis State Com #1 well was drilled as a Morrow test at an orthodox location for 320 acres spacing consisting of the S/2 of said Section 13. The well was unproductive in the Morrow and Atoka formations and was subsequently plugged back to the Canyon formation and completed as an oil well. This well is situated within one mile of the Travis Upper Penn Pool, and is subject to the special pool rules applicable to said pool which require 80 acres spacing, and well to be located within 150 feet of the center of the 4/4 involved. The location of the well does not fall within this provision, and therefore we request approval of an unorthodox location.


