Application for Unorthodox Well Location Hare Gas Com "F" No. 1 Bloomfield Chacra Well San Juan County, New Mexico

By this verified application submitted in triplicate, Amoco requests approval of an unorthodox location for its <u>Hare</u> <u>Gas Com "F" No. 1 to be located 1930' FNL and 2340' FEL</u> of Section 23, T29N, R11W. There are no 'special rules' for the Bloomfield Chacra gas pool; instead, the general state rules apply for the particular county involved, in this instance Rule 103 C II (b), San Juan County. Under that rule, a well must be located within a quarter section not closer than 790' to any outer boundary of the 160-acre tract nor closer than 130' to any quarter quarter section line or subdivision inner boundary.

The reason for the unorthodox location is topographical. There is irrigated land all around the selected unorthodox location. The land owner has requested Amoco to drill at the selected unorthodox location site in order to minimize damage to cultivated lands.

By the attached Verification and Affidavit that is a part of this application, all affected offset operators are being notified by certified mail of this unorthodox location request. If no affected offset operator has an objection, we ask



that each operator so signify on three copies of this letter in the space provided below, sending one copy to you at the NMOCC, one copy to me, and retaining the third copy for their own files. 
