Dear Mr. Johnson:

On March 4, 2004, Environmental Plus, Inc. (EPI), on behalf of Plains All American Pipeline, submitted a Risk Assessment and Site Closure Proposal to the New Mexico Oil Conservation Division (NMOCD) documenting the delineation activities and proposal for remediation of the above-referenced site. The proposal for the risk-based closure was not accepted by the NMOCD, due to the nature of the release (i.e. the front yard of the residence). On January 26, 2005, the North Excavation Closure Proposal was submitted to the NMOCD documenting remedial activities to date and proposing closure of the excavation. Approval was granted to proceed with closure on January 31, 2005. Excavation of the north area of the release site, polyethylene barrier installation, backfilling, grading/contouring and grass seeding constitutes the final closure activity at this site, which this letter documents.

Site Background

The site is located in Lea County, New Mexico at latitude N 32° 36' 55" and longitude W 103° 15' 55" and elevation of approximately 3.560 feet above mean sea level. The release site is on land owned by Ms. Delores Davis. EPI was retained to delineate and remediate the hydrocarbon impacted soil. Based on the previously submitted Site Characterization and Proposal for Risk-Based Closure Report, Ref. #2002-10197, March 4, 2004 and North Excavation Closure Proposal, January 26, 2005, the remedial goals for this site are as follows:

Parameter	Remedial Goals
Benzene ^A	10 mg/Kg
BTEX ^A	50 mg/Kg
TPH	100 mg/Kg

^A-A 100 ppm field analysis may be substituted for laboratory analyses.

The site consisted of a southeastern, southwestern and northern excavation. Hydrocarbon impacted soil above NMOCD remedial goals was excavated and transported to Lea Station Land Farm for treatment. For further background information, please reference the Link Energy Risk Assessment and Site Closure Proposal, Ref. #2002-10197, March 4, 2004 and Plains All American Pipeline North Excavation Closure Proposal, January 26, 2005.

Field Work

Between October 2004 and January 2005, EPI personnel excavated approximately 11,148 cubic yards of soil impacted above NMOCD remedial thresholds from the release area. Impacted soil was transported to the Lea Station Land Farm for treatment. The vertical extent of contamination extended to a depth 16 feet below ground surface (bgs) at the southeastern excavation, 22 feet bgs at the southwestern excavation and 26 feet bgs at the north excavation. Approximately 12,896 cubic yards of imported backfill material was utilized to compact and backfill the excavation.

On December 7, 2004, grab soil samples were collected from five locations in the southeastern and southwestern excavations: north, east, west, and south walls and the excavation floor and submitted to an independent laboratory for confirmatory analyses. Upon laboratory confirmation that NMOCD remedial goals had been achieved, the southeastern and southwestern excavations were backfilled with clean soil and graded to allow natural drainage.

On January 10, 2005, grab soil samples were collected from the northern excavation in 24 locations and a composite sample from the stockpiled backfill material. Samples were collected from each excavation bench to the excavation floor and submitted for laboratory analyses. Analytical results indicated that hydrocarbon impacted soil remained in the north sidewall. On January 24, 2005, after further excavation of the north sidewall, soil samples were collected from the north sidewall and submitted for laboratory analyses. Upon laboratory confirmation that NMOCD remedial thresholds had been achieved, isolation of the remaining source term (i.e. the excavation floor) began. A one foot layer of sand was placed on the excavation floor at 26-foot bgs to act as a cushion for a 20-mil polyethylene liner (reference *Photograph # 7, 8 and 9*). Another one foot layer of sand was placed on the polyethylene liner and the excavation was backfilled with clean soil and graded to allow natural drainage (reference *Photograph #10, 11 and 12*).

The soil was prepared and the seed drilled with a combination drill/roller packer. Approximately 1.4 acres was seeded with Blue Grama grass and Rye. As the first seeding failed to produce any vegetation, in August 2005 the soil was amended with approximately 40 tons of composted dairy manure. Into the amended soil, a mixture of German Millet, Blue Grama, Buffalograss and Bermudagrass was seeded. Final closure activity at this site was accomplished with the conclusion of seeding.

Analytical Data

Confirmatory grab soil samples were collected on December 7, 2005 from the southeastern and southwestern excavations. Samples were placed in a jar provided by an independent laboratory and set on ice for transport to the laboratory for quantification of benzene, toluene, ethylbenzene, xylenes (BTEX) via EPA Method 8260B and total petroleum hydrocarbons (TPH) via EPA Method 8015 Modified. Laboratory analyses indicated TPH and BTEX constituent concentrations in all samples were not detected at or above laboratory method detection limits (MDL). All reported TPH and BTEX constituent concentrations were below NMOCD remedial thresholds as outlined above (reference *Table 2*).

On January 10, 2005, confirmatory grab samples were collected from the northern excavation and composite samples from the stockpiled backfill material. Samples were placed in a jar provided by an independent laboratory and set on ice for transport to the laboratory for quantification of BTEX via EPA Method 8260B and TPH via EPA Method 8015 Modified. Laboratory analyses indicated TPH and BTEX constituent concentrations in all samples were not detected at or above laboratory MDL, with the exception of the north sidewall. Samples collected on January 24, 2005, from the north sidewall following additional excavation indicated that TPH and BTEX constituent concentrations were not detected at or above laboratory MDL. All reported TPH and BTEX constituent concentrations were below NMOCD remedial thresholds as outlined above (reference *Table 1*).

Conclusion

The information provided in this letter documents the final remedial and site closure activities at the Monument 6" release site, located in UL-A of Section 5, Range 37 East, Township 20 South, Lea County, New Mexico. Upon receipt of laboratory confirmation that hydrocarbon impacted soil had been successfully removed, a 20-mil polyethylene liner was installed to isolate the residual hydrocarbons remaining in the excavation floor. Final closure activity at the site consisted of backfilling the excavation, contouring to allow drainage and seeding native and introduced range grass. Based on past and current documentation, EPI, on behalf of Plains All American Pipeline, submits the remedial activities performed at this site have achieved all NMOCD remedial goals in accordance with the approved work plan and request a letter stating that no further action be required.




Figure 1- Area Map Figure 2- Site Location Map Figure 3- Site Map Figure 4- North Excavation Sample Location Map Figure 5- Southeastern and Southwestern Sample Location Map Table 1- Summary of North Excavation Soil Sample Laboratory Analytical Results Table 2- Summary of Southeastern and Southwestern Soil Sample Laboratory Analytical Results Attachment I- Soil Sample Laboratory Results and Chain-of-Custody Form Attachment II- Site Photographs Attachment III- Final C-141













The cause of the release is unknown. Crude oil lines were exposed, however no clamps or leaks were found. It is speculated that hydrocarbon impacts were caused from a leaking valve south of remediation site. Both crude oil lines on the property were removed from the property and capped.

Describe Area Affected and Cleanup Action Taken.*

Initial Area = -18,108 ft² (260'X120'). Hydrocarbon impacted soil above NMOCD remedial thresholds (-11,148 yd³) was excavated and transported to the Lea Station Landfarm for treatment. Residual hydrocarbons in floor of northern excavation were isolated with a 20-mil polyethylene liner. The site was backfilled with clean soil (-12,896 yd³) obtained from Mr. Jimmy Cooper. NMOCD remedial thresholds were: 10 mg/Kg for benzene, 50 mg/Kg for BTEX and 100 mg/Kg for TPH.
