BY MADDOX ENERGY CORPORATION

Gentlemen:

Maddox Energy Corporation has filed a Form C-101 with the Artesia office to re-enter the Queen "B" No. 1 well drilled by Amoco as a Bone Springs wildcat in 1978. The well is located in Unit D, 760 feet FNL and 990 feet FWL of Section 26, T-23-S, R-28-E, Eddy County, New Mexico. It was drilled on forty (40) acre spacing.

Maddox desires to drill plugs and clean out to approximately 7000 feet and attempt completion in the Bone Springs. After the well was drilled and plugged the Bone Springs discovery well, the Delta Drilling Company, Culebra Bluff No. 3, was completed approximately 3/4 mile NNE. Temporary special rules were adopted in late 1979 which call for eighty (80) acre spacing and, therefore this well is now in an unorthodox location.

On September 15, 1980, we sent waivers for the unorthodox location to all offset operators by Certified Mail. Due to a misunderstanding, we did not simultaneously notify your office of our request.

We respectfully request your approval of our application to re-enter this well and an exception for the unorthodox location.

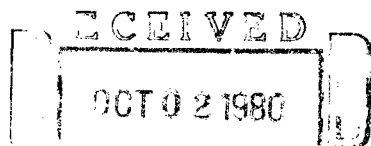
