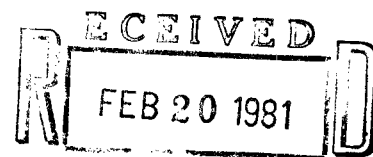

Gentlemen:

ARCO Oil and Gas Company requests administrative approval of an unorthodox location and simultaneous dedication of the W. H. Harrison "C" WN No. 5 to the existing non-standard 240-acre proration unit comprising the NW/4 and the N/2 SW/4 of Section 20, T-24-S, R-37-E, Lea County, New Mexico. The unit, established under Order No. R-2867, is currently classified as marginal with all acreage dedicated to the W. H. Harrison "C" WN No. 3 located in Unit L of said Section 20.

The W. H. Harrison "C" WN No. 5 was drilled and completed in 1972 in the Langlie Mattix Oil pool. The Jalmat Yates Seven Rivers was recently perforated and plan is to complete the well as a Jalmat and Langlie Mattix dual. The existing unit well, W. H. Harrison "C" WN No. 3 is currently making an average 241 MCFD. A Jalmat completion in the W. H. Harrison "C" WN No. 5 should allow the proration unit to produce its full allowable and help prevent waste and any unnecessary drainage.

ARCO Oil and Gas Company believes approval of these requests will be in the interest of conservation, protect correlative rights, and allow for more complete recovery of the Jalmat gas reserves.

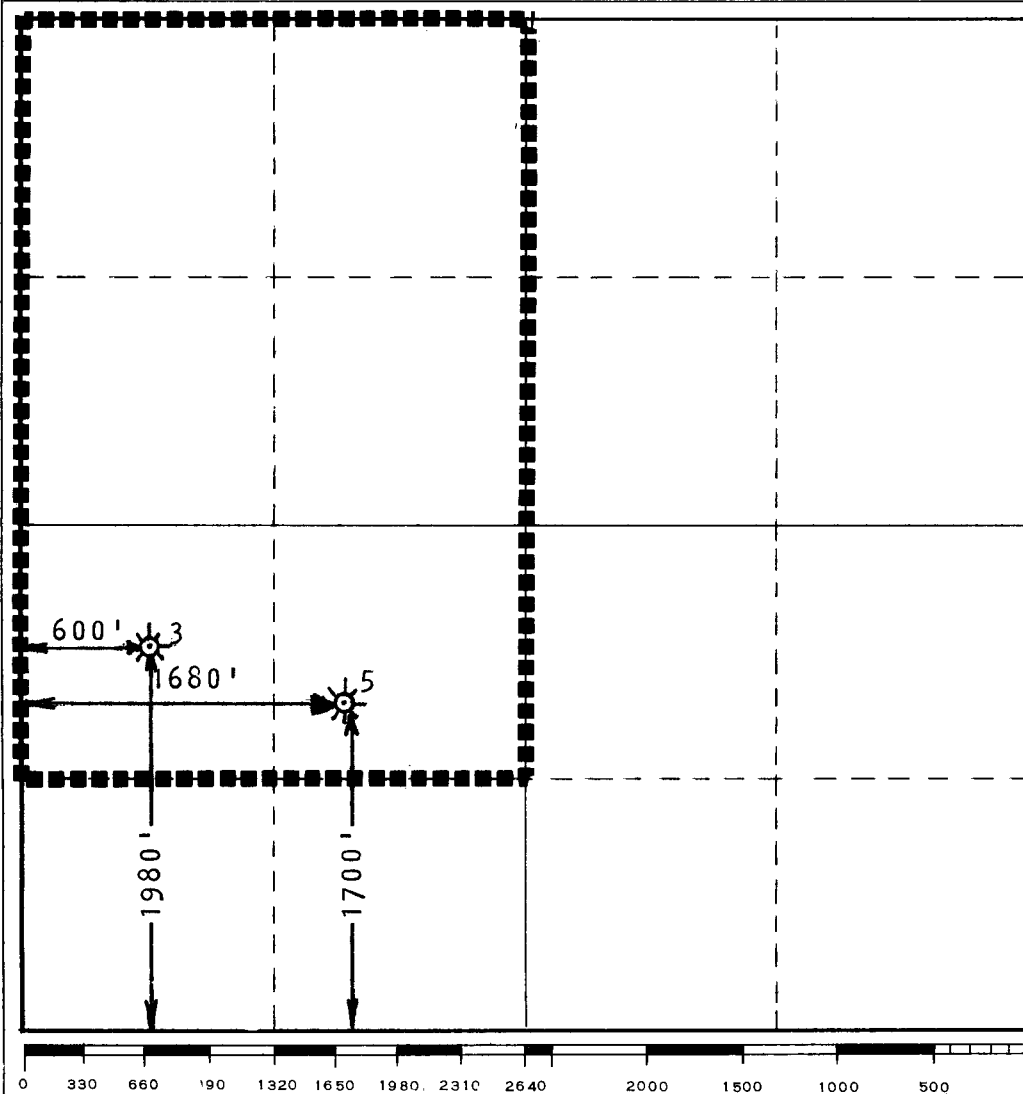
