

Application for Unorthodox Locations Morris Gas Com "C" No. 1 & Sullivan Gas Com "C" No. 1 Undesignated Gallup Field Poo / San Juan County, New Mexico

Amoco Production Company hereby requests approval of our Morris Gas Com "C" No. 1 located 1845' FSL and 1500' FWL Section 26, T29N, RIOW, San Juan County, New Mexico, and the Sullivan Gas Com "C" No. 1 located 940' FSL and 1450' FWL, Section 28, T29N, R10W, San Juan County, New Mexico.

The Morris Gas Com "C" No. 1 and the Sullivan Gas Com "C" No. 1 were recently recompleted from producing Dakota wells to the Undesignated Gallup Field. Both of the above wells were originally drilled at orthodox locations.

The attached Form C-102 shows the location of the well, and a nine-section plat is also included as required.

There are no offset Gallup Wells.




