On behalf of Wagner Oil Company, this letter will serve as written notification in accordance with 20.5.700, 701, 702, and 703 NMAC. The following information pertains to the reportable release of crude oil that was discovered on Wednesday, August 9, 2006 at the Wagner Oil Company, Geronimo Federal Battery #3 located in Lea County, New Mexico.

2. Geronimo Federal Battery #3
Section 31, Township 19S, Range 33 East
Lea County, New Mexico
The storage tank system was located on the far west side of the Wagner Oil Company property with the storage tank area being located on the southwest corner of the Geronimo Federal Battery #3.
3. The crude oil release was discovered at the Geronimo Federal Battery #3 on Wednesday, August 9, 2006 at approximately 1200 hours.
4. The source of the release was a hole in a 300 barrel crude oil storage tank that was believed to be the result of corrosion on the crude oil storage tank.
5. Approximately 230 barrels of crude oil was released into the storage tank secondary containment dike located at the Geronimo Federal Battery #3. The release was the result

of a hole located on a 300 barrel crude oil storage tank that had developed due to corrosion.


6. The estimated volume of the crude oil release was 230 barrels.
7. As per Mr. Raymond Dodd, Wagner Oil Company, approximately 185 barrels of the released crude oil was removed from the storage tank secondary containment dike via vacuum truck with the remaining crude oil having been absorbed by the soil. Mr. Dodd further stated that the contaminated soil would be removed from the affected areas, mixed with fresh soil, left to sit temporarily, and then hauled off for proper disposal.
