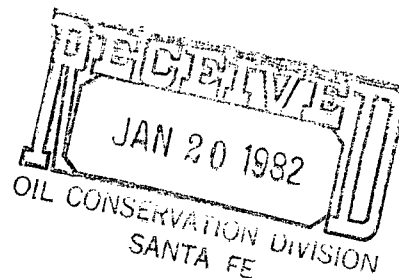

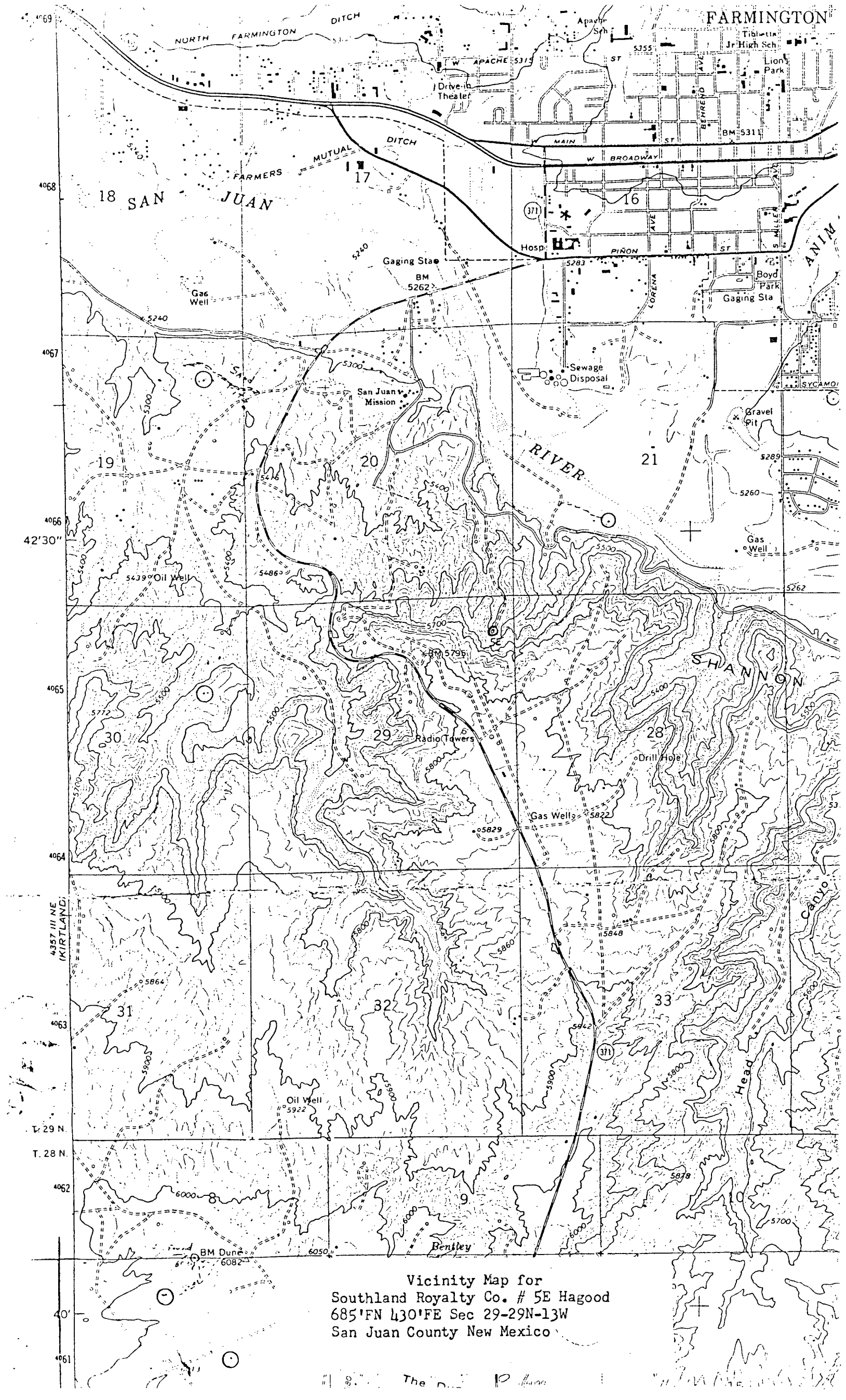

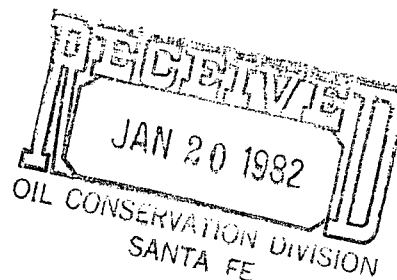
Vicinity Map for
