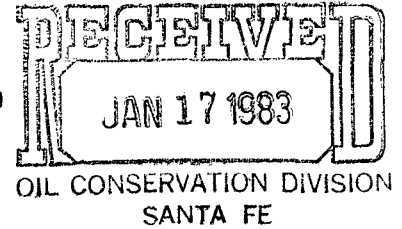

Dear Mr. Stamets:

Northwest Pipeline Corporation requests permission to drill the above captioned well in an unorthodox location due to topographical reasons. This well is staked at the head of Manuel Canyon and is as close as possible to the San Juan 30-5 Unit #68. As can be seen from the topographical map this canyon bottom is the only accessible location in the SW/4 of Section 25.

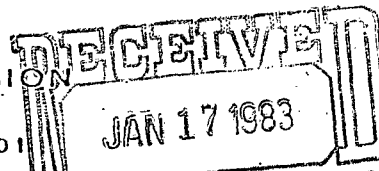
The South half of Section 25 has been dedicated to this Dakota well. The South half consists of 270.04 acres and is Non-Standard due to a variation in the legal subdivision of the U.S. Public Land Survey. Northwest Pipeline requests administrative approval to produce this well as a Non-Standard gas unit.

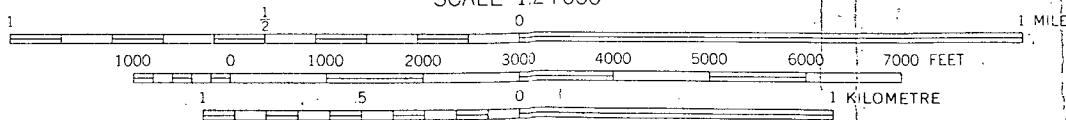

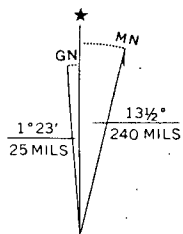

NATIONAL GEODETIC VERTICAL DATUM OF 1929

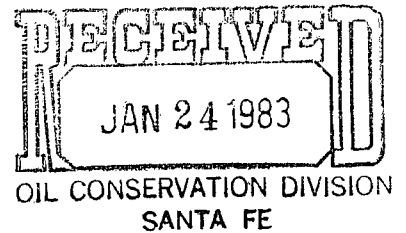


1911 AND 1963 MAGNETIC NORTH
