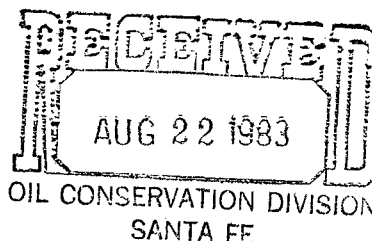

Dear Sir:

Santa Fe Energy, Exploration Department, is proposing an unorthodox location (990' FEL, 990' FNL) in Section 28, T22S, R27E, Eddy County, New Mexico. Reasons for this location are as follows:

- (1) Isopaching of clean Morrow Sands indicates the trend of sand reservoirs trends in a northwest-southeast direction.
- (2) A cumulative gas production map of the Morrow sands indicates best production is oriented in a northwest-southeast direction. This information supports the Morrow sand isopach (Map 1).
- (3) The Morris Antweil #1 Randall (1980' FNL and 1980' FSL) Section 21, T22S, R27E is a poor well. It was plugged in 1976 after producing 49,612,000 CFG. Santa Fe Energy's proposed location would be 3700' southeast and 3000' south of the productive Santa Fe #1 Walker.
- (4) The Santa Fe #1 Walker (990' FEL, 1980' FSL Section 21) encountered an excellent Morrow reservoir. The well potentialed for 8.4 million cubic feet of gas per day, CAOF).

The location Santa Fe Energy Company has proposed is the most logical one based upon knowledge of sand trends, good reservoir conditions, and production data in extending gas production to the southeast in the South Carlsbad Field.

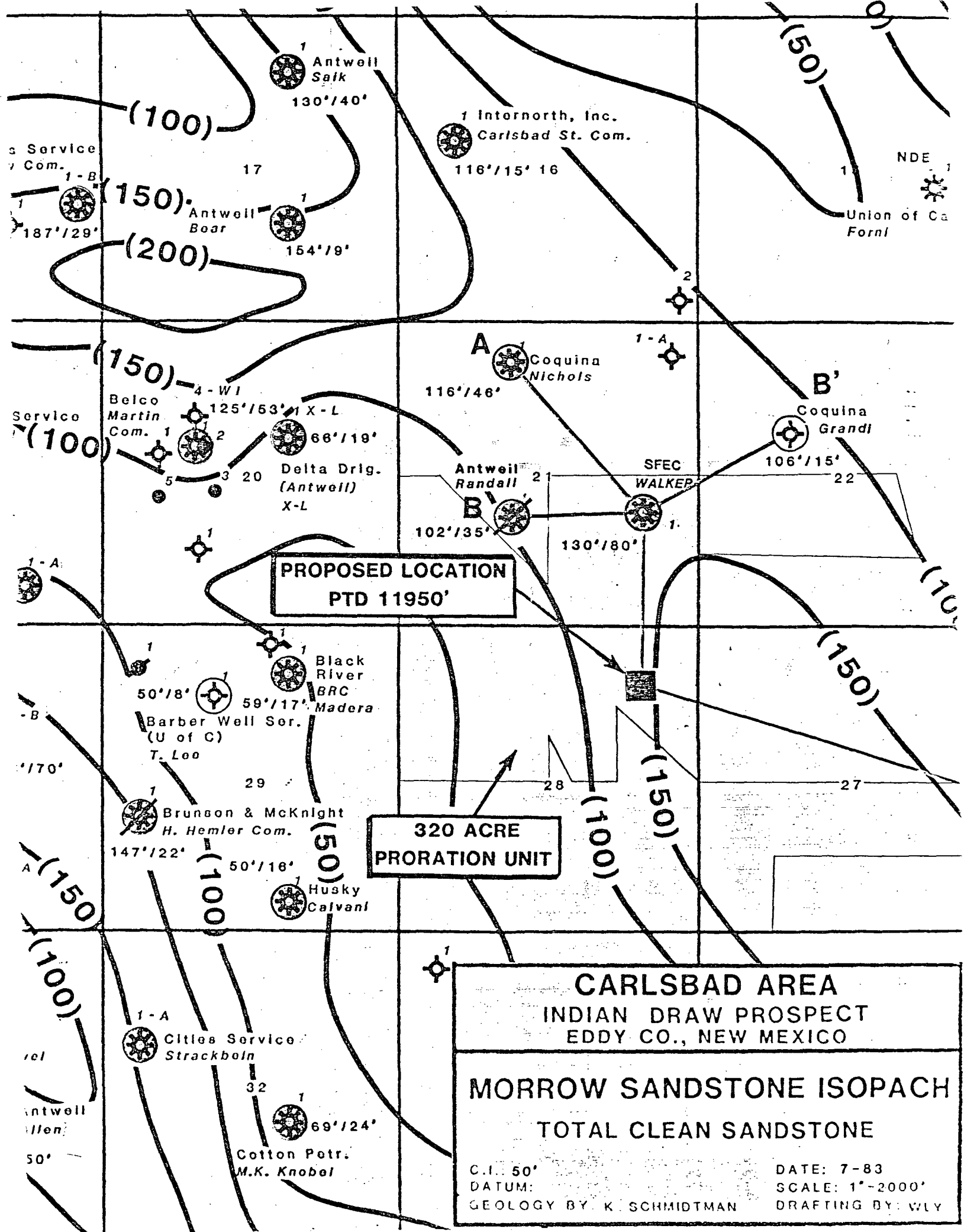

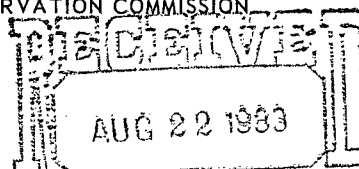

Drill a 26" hole with rathole machine. Run and cement 40' of 20" conductor. Move in and rig up rotary tools. Drill a 17 1/2" hole to 600' with fresh water spud mud. Run, set and cement 13 3/8" casing. WOC 12 hours (compressive strength of cement to be 500 psi or greater). Install casinghead and nipple up BOP stack with choke manifold. Test BOP and casing to 600 psi. Drill 12 1/4" hole to 5325' with brine. Run open hole logs from TD to 2000'. Run, set and cement 9 5/8" casing. WOC 12 hours (compressive strength of cement to be 500 psi or greater). Test BOP and choke manifold to 5000 psi. Test spherical preventer to 2500 psi. Test casing to 2500 psi. Drill shoe and test casing seat to 14 ppg MWE. Drill 7 7/8" hole to 11,860' allowing hole conditions to dictate mud properties. Run DST's and core as indicated by samples and shows. Run open hole logs from TD to 5325'. Run, set and cement 5 1/2" casing.
