Santa Fe Energy Company, Exploration Department, is proposing an unorthodox location (660' FNL, 990' FWL) in Section 26-22S-27E, Eddy County, NM. Reasons for this location are as follows:

- 1. The Apexco Henri Grandi No. 1 (1880' FSL, 1980' FWL, Section 26-22S-27E) tested a considerable amount of formation water from the Morrow formation during drilling and completion. This well is down-dip to the proposed Henry location and was found to be non-commercial and wet from the Morrow (See Map 1). Santa Fe Energy Company's proposed location is structurally approximately 100 feet updip to the Apexco well in the Morrow formation. It is Santa Fe Energy Company's interpretation that the requested unorthodox location will be far enough up structure at the Morrow level to be above any gas/water contacts.
- 2. The "Nichols Sand" is one of Santa Fe Energy Co's major objectives in the Morrow formation. From the interpretation, (see Map 2) the "Nichols Sand" is probably best developed in the northwest corner than any other place in Section 26. This interpretation further supports the unorthodox location.

The location Santa Fe Energy Company has proposed is the most logical one based upon knowledge of the Morrow formation in the South Carlsbad Field.






