When the Montoya depleted, the well was recompleted in the Justis Fusselman pool in July, 1979. The Fusselman has since watered out and a successful recompletion has been made in the Justis Tubb/Drinkard Pool.

Arco Oil & Gas Company believes approval of this request will be in the interest of conservation, will protect correlative rights, and will allow for a more complete recovery of Tubb/Drinkard reserves from the subject acreage.


