

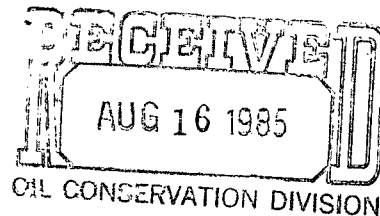

Dear Mr. Stamets:

Arco Oil & Gas Company respectfully requests administrative approval for an unorthodox location for the Wimberly WN #11 in the Justis Tubb/Drinkard Pool. The well is located 990' FNL & 1490' FWL of Section 24, T-25-S, R-37-E, which is 330 feet from the nearest lease line and 170 feet from the 40 acre proration unit boundary. It is requested that the #11 share the existing proration unit dedicated to the Wimberly WN #2 which is producing from the Justis Tubb/Drinkard pool. The C-102 acreage dedication plat showing the locations of the #2 and #11 is attached.

The Wimberly WN #11 was drilled in June, 1977, and was originally completed in the Justis Montoya pool. The unorthodox location was approved under Order No. R-5430-A. When the Montoya depleted, the well was recompleted in the Justis Fusselman pool in July, 1979. The Fusselman has since watered out and a successful recompletion has been made in the Justis Tubb/Drinkard Pool.

Arco Oil & Gas Company believes approval of this request will be in the interest of conservation, will protect correlative rights, and will allow for a more complete recovery of Tubb/Drinkard reserves from the subject acreage.

The offset operators have been sent a copy of this request by registered mail. A list of the offset operators is attached. Thank you for your prompt consideration.

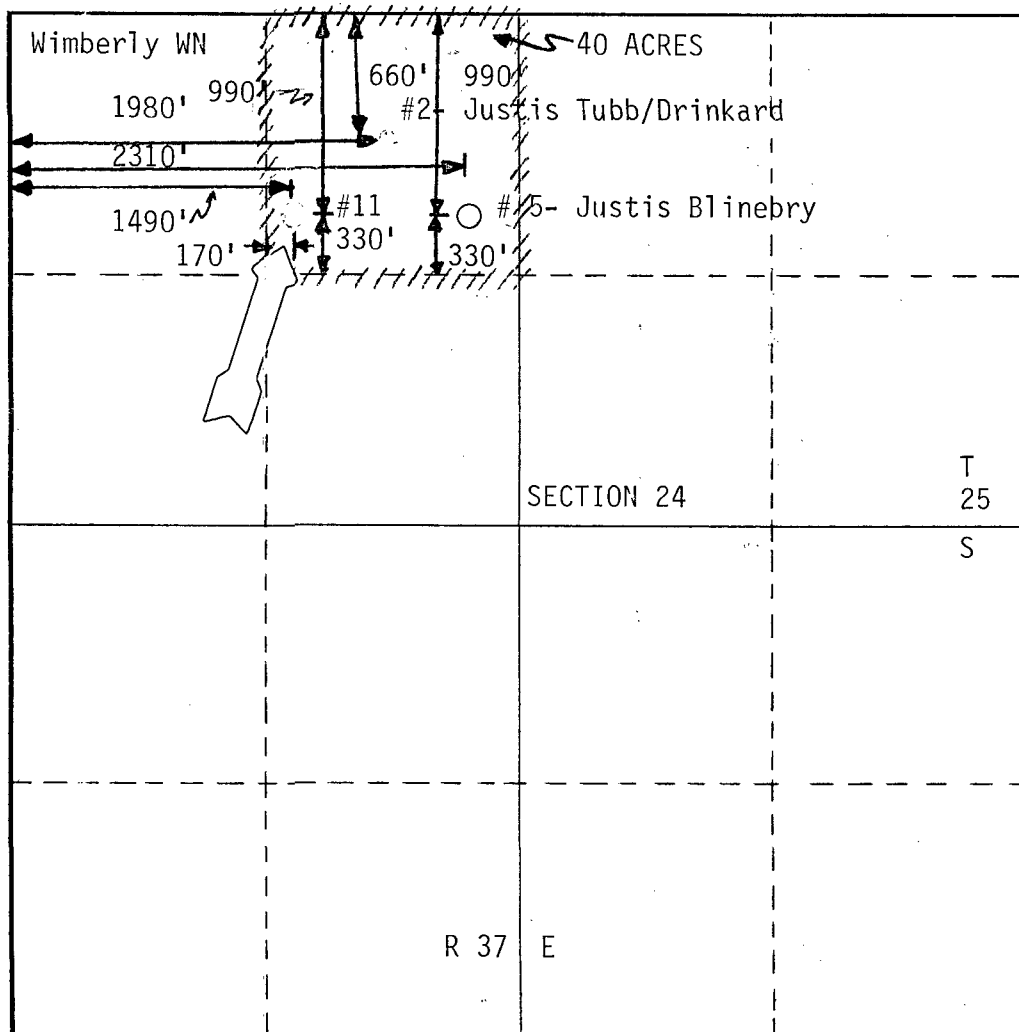

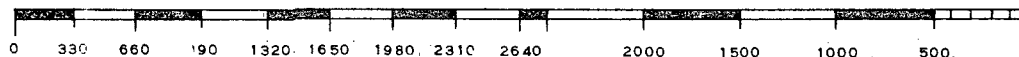

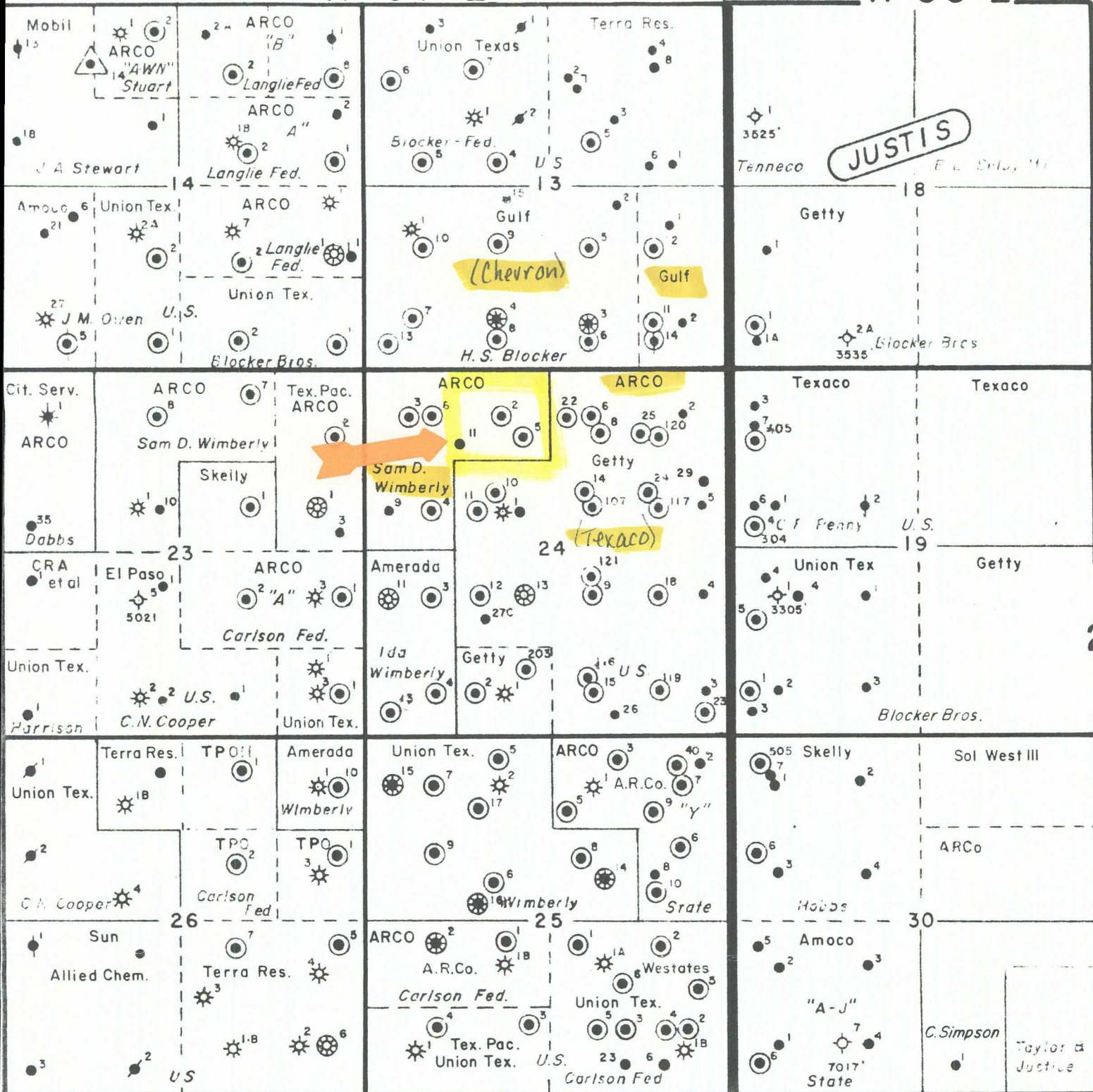
