Re: Application for an Unorthodox Location in the Scharb - Bone Springs Oil Pool

Dear Mr. Stamets:

POE PROPERTIES, INC., P. O. Box 9769, Fort Worth, Texas 76102 is the operator of Federal Oil & Gas Lease NM-24166 which covers the E½NE4 of Section 9,7 T. 19S., R. 35E., Lea County, New Mexico.

Production from applicant's #1 SPRINKLE FEDERAL WELL, located 2063' FNL and 841' FEL of Section 9 and completed on 7-13-83 in the Bone Springs pay zone (9526'-9604'), is producing less than two-thirds of the top allowable for the Scharb - Bone Springs Oil Pool.

Production from applicant's #2 SPRINKLE FEDERAL WELL, located 660' FNL & 330' FEL of Section 9 and completed on 2-6-84 in the Wolfcamp pay zone (10,544'-10,560), has declined to only 2 - 3 BOPD.

Applicant proposes to abandon the Wolfcamp zone in Well #2 and recomplete the well in the Bone Springs formation (9500'-9650').

The special rules for the Scharb - Bone Springs oil pool make a provision whereby an exception to the footage requirement that a well be located within 200' of the center of either quarter-quarter section may be approved without notice and hearing; provided that, the well was previously drilled to another horizon, and provided that, the well is located no nearer than 330 feet to the outer boundary of the proration unit.


Accordingly, POE PROPERTIES, INC. respectfully request administrative approval of an unorthodox oil well location in the Scharb - Bone Springs oil pool for WELL #2 SPRINKLE FEDERAL located 660' FNL and 330' FEL of Sec. 9-19S-35E.
