ARCO Oil and Gas Company respectfully requests administrative approval to drill its Seven Rivers Queen Unit No. 73, a proposed producing well in an active waterflooding unit, at an unorthodox location of 1450' FNL & 1250' FWL, Section 34, Township 22 South, Range 36 East, Lea County. The well is to be drilled to a TD of 3870' to test the Seven Rivers Queen formations. In ARCO's opinion, completion of the well at the proposed location will provide an efficient production and injection pattern within a secondary recovery project. This well is expected to recover unswept oil by increasing the amount of floodable pay and by increasing the injection efficiency due to increased continuity. 
