

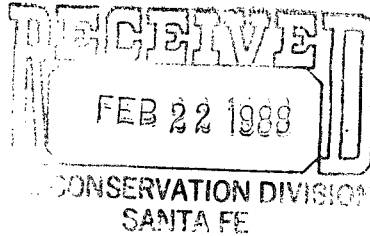

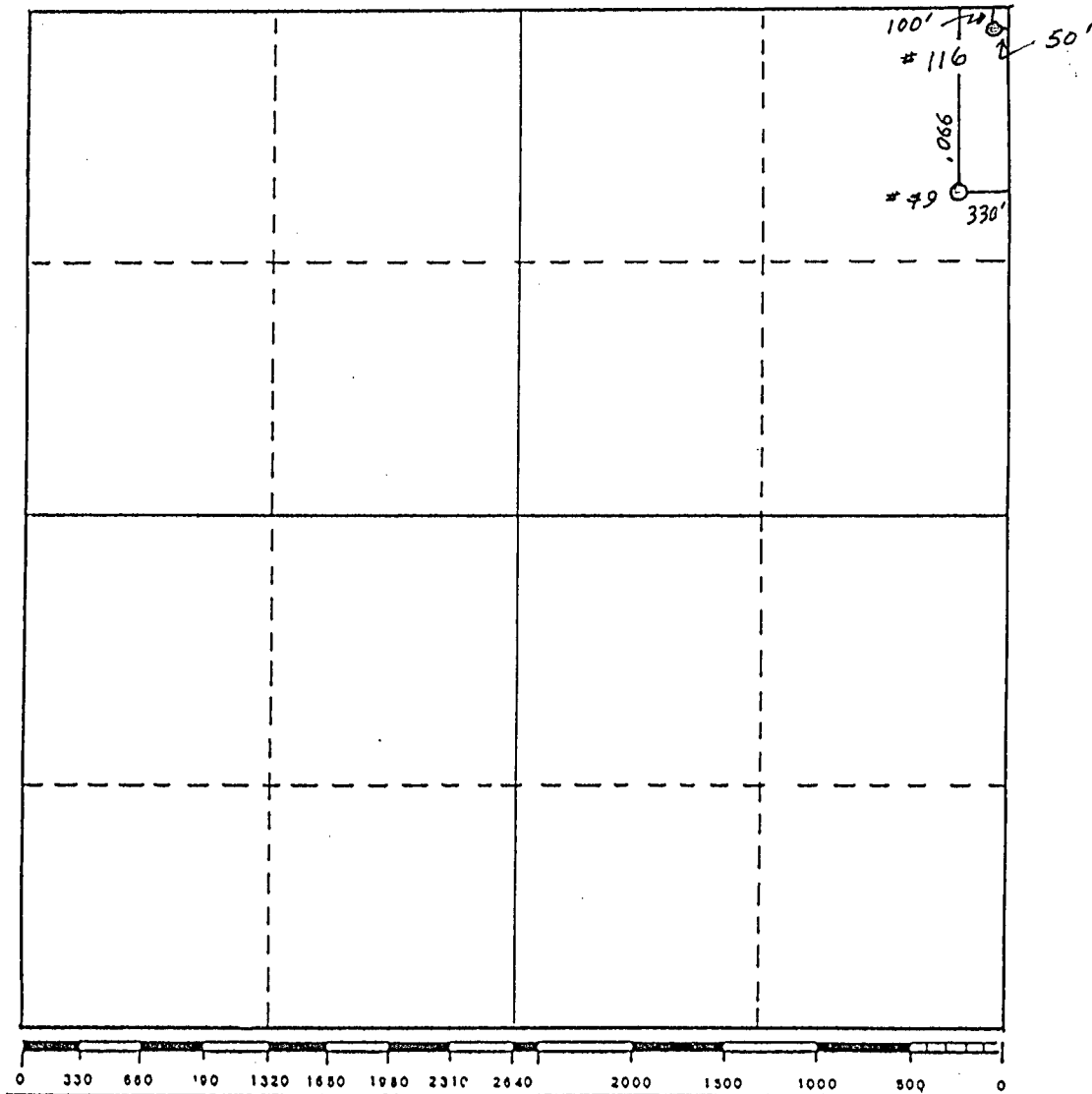

WELL LOCATION PLAT

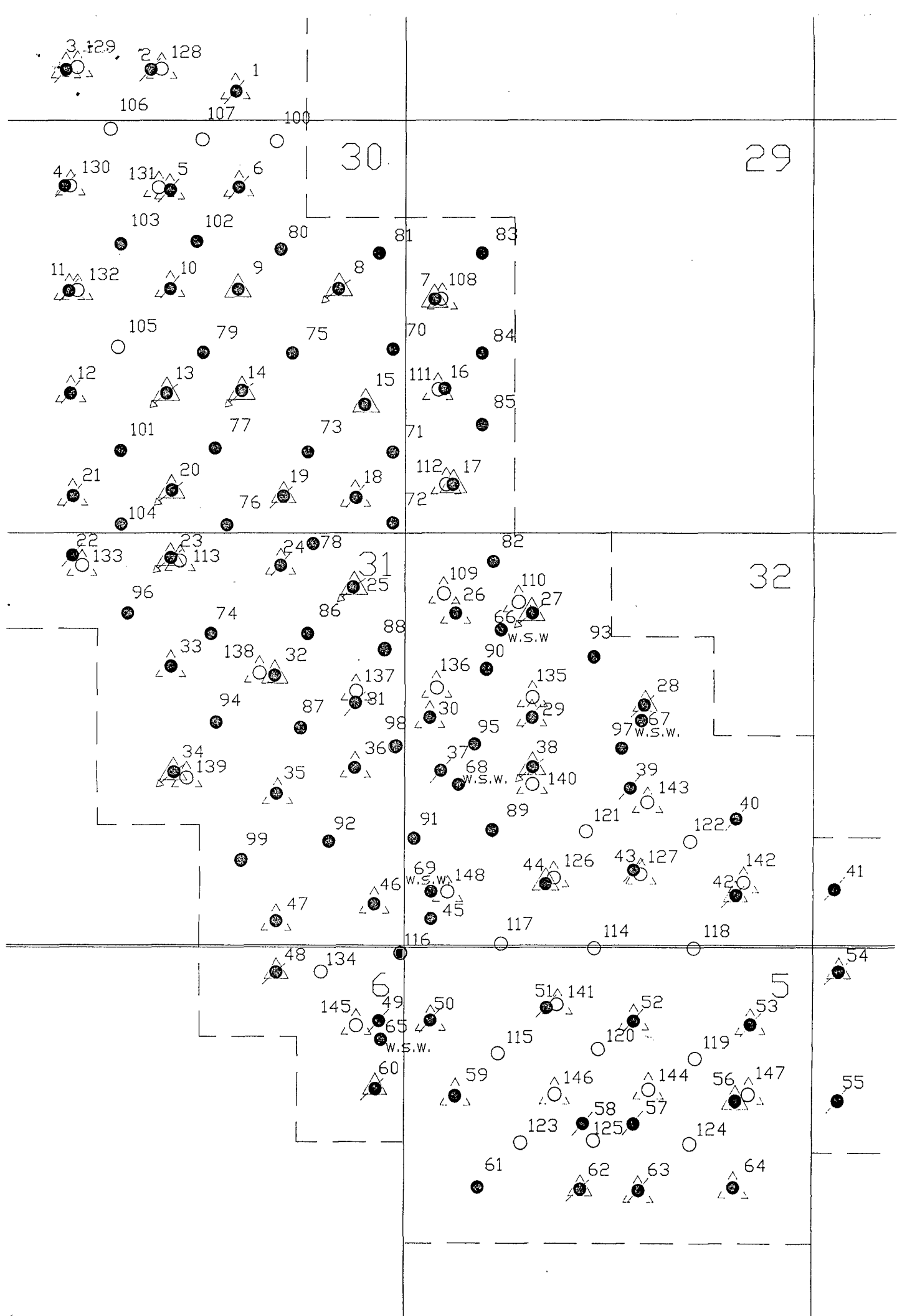

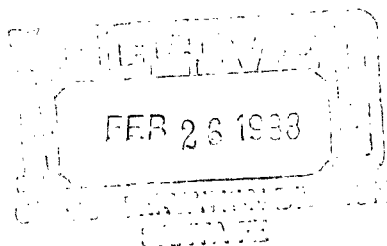
