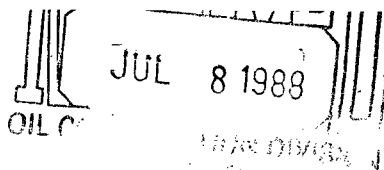

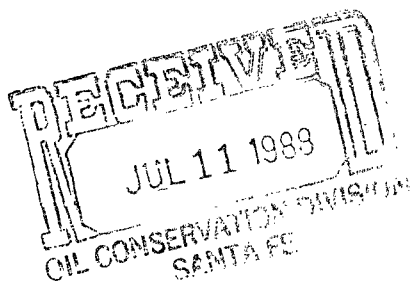

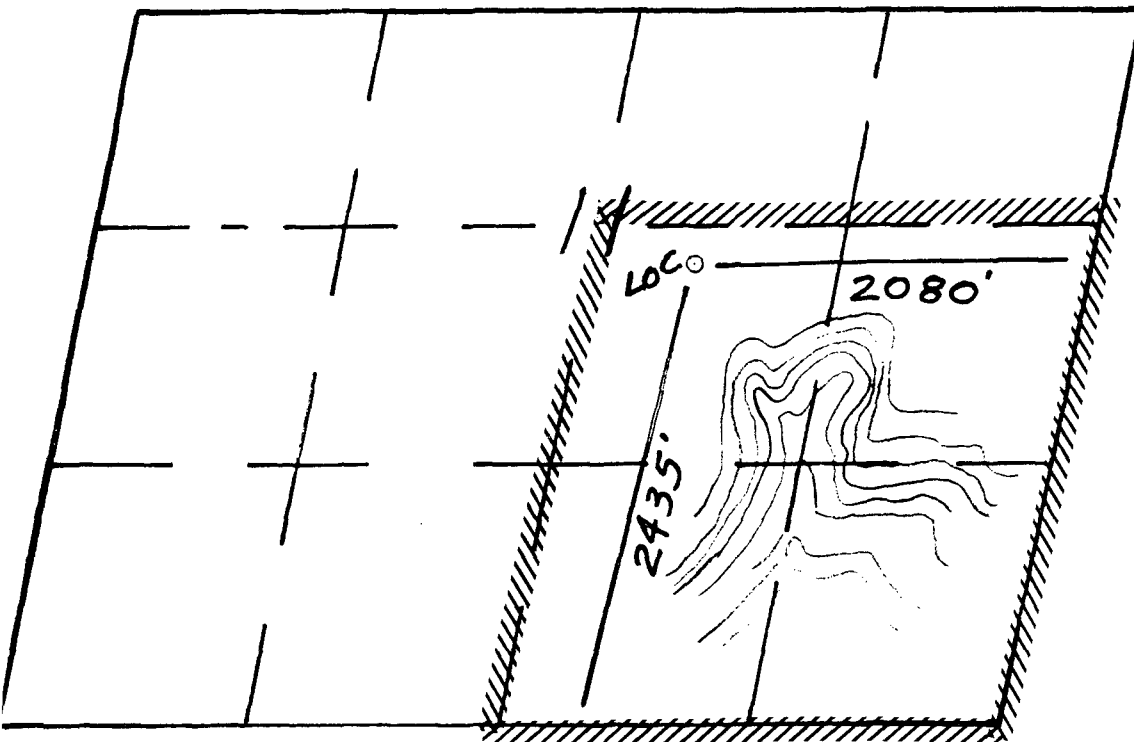

This is a detailed topographic map of the San Juan National Monument area in New Mexico. The map is oriented with North at the top. This is a request for administrative approval for an unorthodox gas well location in the Undesignated Fruitland Pool.


