Gentlemen:

My letter of March 16th requested approval of the unorthodox location for the captioned well, 660'fs&el of Section 6 19S 18E, based on topographical reasons.


My archaeologist, Bob Martin with Pecos Archaeoloigsts of Carlsbad advised me earlier this week that the proposed drillsite was located within an archaeological site.

I met with the surveyors, the BLM representative, the surface lessee, my archaeologist and dirt contractor to resolve the problem yesterday. They pinned me down to a small area between the solid dolomite hillsides and the relatively flat archaeological site (660'fn & 330'fel of Section 7 19S 18E and on the same lease, approximately 1320 feet from the previous stake.

Enclosed is a copy of the USGS topo sheet showing the archaeological site in red and the area of topographical problem areas in green.

The two other leasehold owners within the proposed 11,782.54 acre unit are aware of the unorthodox location problem and do not object its location.



This hand delivered letter is written to request Oil Conservation Division administrative approval of an unorthodox wildcat location, for topographic reasons.

John West Engineering (Surveyors) and myself attempted to stake the captioned well for an orthodox 320 acre spacing unit wildcat drillsite at 1,650' fs & 1,650' fel of Section 6 19-S 18-E. We encountered a steeply sloping solid dolomite outcrop on which a drilling pad could not be constructed without great effort which would require considerable destruction of local terrain by blasting.

After reviewing alternate locations, I decided to move the drillsite stake to 660' fs & el of Section 6 19-S 18-E, one of the few level spots in section 6. At this time I thought this would be an orthodox location for a 160 acre spacing unit for the 2,600 foot Lower Pennsylvanian target zone. I am now aware that 320 acres is required for Lower Pennsylvanian, regardless of depth.

Enclosed is a copy of the USGS Topographic map of the area, indicating very rugged terrain. I have also indicated the original proposed drillsite and the present stake location.

A copy of this letter and plat is being sent by certified mail to the two other leasehold owners within the proposed 11,782.54 acre unit.





ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on March 15, 1989, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 22nd day of March, 1989, the Division Director, having considered the testimony, the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) The applicant, Texmex Seven Ltd., seeks approval of the Pretty Bird Unit Agreement for all oil and gas in any and all formations underlying those lands described in Exhibit "A" attached hereto and made a part hereof.
- (3) No interested party appeared and objected to the proposed unit area.
- (4) All plans of development and operation, and creations, expansions or contractions of participating areas, or expansions or contractions of the unit area should be submitted to the Director of the Division for approval.
- (5) Approval of the proposed unit agreement should promote the prevention of waste and protection of correlative rights within the unit area.

IT IS THEREFORE ORDERED THAT:

- (1) The Pretty Bird Unit Agreement is hereby approved for all oil and gas in any and all formations underlying those lands described in Exhibit "A" attached hereto and made a part hereof.
- (2) The plan contained in said unit agreement for the development and operation of the unit area is hereby approved in principle as a proper conservation

measure; provided however, notwithstanding any of the provisions contained in said unit agreement, this approval shall not be considered as waiving or relinquishing, in any manner, any right, duty or obligation which is now, or may hereafter be, vested in the Division to supervise and control operations for the unit and production of oil and gas therefrom.

(3) The unit operator shall file with the Division an executed original or executed counterpart of the unit agreement within 30 days after the effective date thereof; in the event of subsequent joinder by any other party or expansion or contraction of the unit area, the unit operator shall file with the Division, within 30 days thereafter, counterparts of the unit agreement reflecting the subscription of those interests having joined or ratified.

(4) All plans of development and operation, all unit participating areas and expansions or contractions of the unit area, shall be submitted to the Director of the Oil Conservation Division for approval.

(5) This order shall become effective upon the approval of said unit agreement by the Commissioner of Public Lands for the State of New Mexico and the Director of the appropriate agency of the United States Department of the Interior; this order shall terminate ipso facto upon the termination of said unit agreement; and the last unit operator shall notify the Division immediately in writing of such termination.

(6) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
