Accordingly, the Examiner's hearing for these two cases now docketed for April 26, 1989 can now be dismissed.

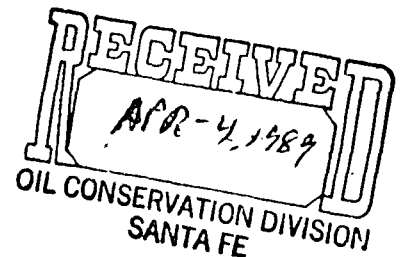
