McClellan Oil Corporation requests administrative approval for a non standard Pecos Slope Abo gas well location as provided for under NMOCD Rule 104F. This lease is on Federal surface and minerals.


The enclosed map shows the topography problem, the drainage problem and the surface equipment problems. The well was originally proposed to be located on a standard location at 660' FSL & 1980' FWL in Sec. 1. However, a deep canyon and steep walls prohibited construction of a location. Also, BLM Resource Management Staff would not approve of the original location. The well was moved to 1650' FSL and 1980' FWL but was located on a fence line dividing two pastures. The BLM requested we move the location to 1525' FSL & 1915' FWL to avoid the fenceline.

The well was permitted by the BLM and was approved by the BLM's range management. The enclosed lease map shows that the well does not affect offset operators. We have notified the offset operators by certified mail of our request for a non-standard location.

We appreciate your approval for a non-standard location. Should you need more information please contact me.
