XTO Energy Inc. (XTO) requests that this surface commingle be amended to add in the Ohio D Government #3 (API No. 30-045-31822). This well will be a new Basin Fruitland Coal completion. This well will be equipped with its own allocation meter for gas measurement. Adding this well to the existing surface commingle will greatly enhance productivity by utilizing an existing compressor. It should also be noted that Marathon Oil Company removed the second CDP sales point at the Ohio F Government #1A. The current sales point for this surface commingle is at the Ohio E Government #18-1. There are no other changes to the initial surface commingle application. Interest owners for this surface commingle are all common and identical.

### **Proposed Testing Procedure and Schedule**

All of the wells are or will be equipped with an allocation meter to measure each individual well before any gas is commingled at the compressor. Fuel usage for the CDP compressor will be allocated based on each well's production. The point numbers in the table below correspond to the wells location on the attached topographic map.
