Gentlemen:

We, on behalf of Evergreen Operating Corporation, hereby make application for approval of the location of the Rosa Unit #285 well to be located 1668' FNL 301' FEL of Section 3, Township 31 North, Range 4 West, Basin Fruitland Coal Gas Pool, Rio Arriba County, New Mexico.

The reason for the non-standard location is due to topography and to protect wildlife habitat.

We attempted to place the location on the ridge to the west at a standard location, but the Forest Service objected due to the need for "scalping" the hill.

This is the only usable location within the northeast quarter of Section 3.

The attached exhibits show the situation at the location and surrounding area.

All offset operators and lease owners are being notified by certified mail at this mailing. The Return Receipt Cards will be provided when they are returned.

- EXHIBIT B Enlarged copy of Topographic Map: shows the location to be on a bench of a steep hillside. (Notice that the Contour Interval is 40 feet.) The location is situated to avoid excessive cutting into the top of the ridge to the west. The terrain falls off rapidly to the south and west from the location which prevents moving further west. There is no other viable location within the northeast quarter.
- EXHIBIT C Ownership and Offset Well Location Plat: shows the location of the Rosa Unit #285 relative to the locations of the #284 in the southwest quarter of Section 3 and the #282 in the southwest quarter of Section 2.
- The distance between wells within Section 3, being 3972 feet, and between the #285 and the #282 wells, being 2658 feet, are well within the tolerances of standard well spacings as set out in the pool rules by Order R-8768 and shown on Exhibit E.
- The ownership and offset wells are also shown on this exhibit.
- EXHIBIT D Location Windows Plat showing distances between points: shows the distances between wells in standard spacing situations with 1601.25 feet being the minimum and 5232.59 feet maximum for wells on adjacent drill tracts.
- EXHIBIT E Location Windows Plat with wells spotted: shows the "windows" for standard locations as provided by Order R-8768 with the #285 and #284 wells spotted in their approximate positions.

# STANDARD LOCATION WINDOWS FRUITLAND COAL WELL (320-ACRE DRILL TRACT)

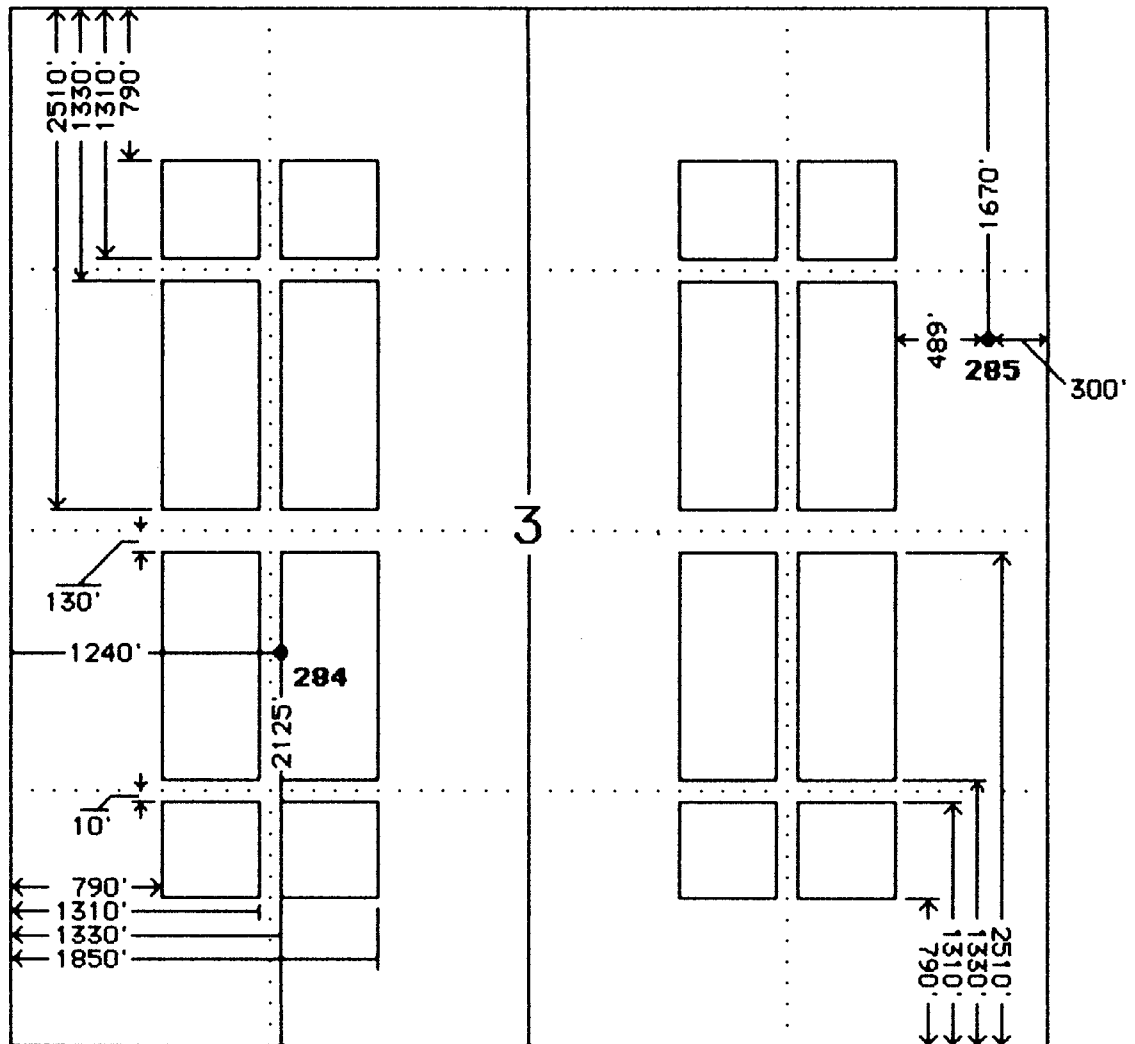


