Dear Ms. Staley:

Reference is made to your application dated October 19, 1995 for a non-standard Basin-Fruitland coal gas well location for your existing Sanchez Gas Com "C" Well No. 1 (API No. 30-045-25618), located 750 feet from the North line and 660 feet from the East line (Unit A) of Section 28, Township 29 North, Range 10 West, NMPM, San Juan County, New Mexico. According to the well records on file with the New Mexico Oil Conservation Division, the Sanchez Gas Com "C" Well No. 1 was drilled in 1983 and dually completed in the Blanco-Mesaverde Pool and Armenta-Gallup Oil Pool. By Division Administrative Order NSL-2150, dated September 17, 1985, this location was approved as an unorthodox gas well location for the Mesaverde gas producing interval, the location was considered to be a standard oil well location for the Gallup interval.

It is our understanding that the Gallup interval was abandoned and plugged-back in 1993 and the well is currently producing as a single completion from the Mesaverde interval, which is also to be plugged-back and abandoned and recompleted in the Basin-Fruitland Coal (Gas) Pool. Pursuant to the "*Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool*", as promulgated by Division Order No. R-8768, as amended, the location of this well is also considered to be "unorthodox".


It is our further understanding that said well is to be a replacement well for your Pollock Com "E" Well No. 1 (API No. 30-045-25743), located at an unorthodox coal gas well location (approved by Division Administrative Order NSL-3064, dated October 23, 1991) 860 feet from the South line and 805 feet from the East line (Unit P) of said Section 28, which is currently dedicated to the E/2 of said Section 28 being a standard 320-acre gas spacing and proration unit for said pool.

By the authority granted me under the provisions of Rule 8 of said Order No. R-8768, as amended, the above-described unorthodox coal gas well location for the Sanchez Gas Com "C" Well No. 1 is hereby approved.

Reference is made to your application dated October 1, 1991 for a non-standard Basin-Fruitland coal gas well location for your existing Pollock Com "E" Well No. 1 which was drilled in 1983 and dually completed in the Armenta Gallup Oil Pool and Blanco Mesaverde Pool at a standard location for both zones 860 feet from the South line and 805 feet from the East line (Unit P) of Section 28, Township 29 North, Range 10 West, NMPM, San Juan County, New Mexico.

It is my understanding that both the Gallup and Mesaverde zones will be properly plugged back and said well will be recompleted to the Basin-Fruitland Coal Gas Pool, which pursuant to the Special Rules and Regulations for the Basin-Fruitland Coal Gas Pool as promulgated by Division Order No. R-8768, as amended, is unorthodox. Further, the E/2 of said Section 28 shall be dedicated to the well forming a standard 320-acre gas spacing and proration unit for said pool.

By authority granted me under the provisions of Rule 8 of the Division Order No. R-8768, as amended, the above described unorthodox coal gas well location is hereby approved.
