Re: Application for Administrative Unorthodox Gas Well Location Eumont Yates 7RQ (Pro Gas) 1650 FSL and 2310' FWL Section 25, T-19S, R-36E Lea County, New Mexico

Gentlemen:

Amerada Hess Corporation respectfully requests administrative approval of our application for the unorthodox gas well location.

We are planning to recomplete the State "T" #8 in the Eumont Yates Seven Rivers Queen Gas Pool. The State "T" #8 is located 1650' FSL and 2310' FWL, Section 25, T-19S, R-36E, Lea County, New Mexico. The well was officially abandoned in the Eunice Monument G/SA Zone in January, 1992. The proposed location is within an existing 160 acre proration unit, the State "T" Lease consisting of the E/2 W/2 of Section 25, T-19S, R-36E. The proposed location is unorthodox by virture of being within 660' of the outer Eastern boundary of the proration unit.

This will be the second Eumont Well within the subject proration unit. The State "T" #3 shown on the attached plat, currently produces 100 MSCFD.

Since the minimum gas allowable was increased by Order No. R-8170-G, December 1, 1990 to 600 MCFD for a 160 acre proration unit, the proposed well will enable Amerada Hess Corporation to economically increase gas production from the unit. A well location and acreage dedication plat is attached as well as a map showing ownership of all leases offsetting the proration unit for which the unorthodox location is sought, and also the wells completed thereon. Furthermore, a copy of this letter has been sent by certified mail to Chevron, Oryx, Owens and Texaco, the four offset operators of offset proration units.





THE APPLICATION OF AMERADA PETROLEUM CORPORATION FOR AN ORDER GRANTING APPROVAL OF AN EXCEPTION PURSUANT TO RULE 7 (a) OF ORDER NO. R-370-A IN ESTABLISH-MENT OF AN UNORTHODOX GAS PRORATION UNIT OF 160 CONTIGUOUS ACRES CONSISTING OF THE EAST HALF OF THE WEST HALF OF SECTION 25, TOWNSHIP 19 SOUTH, RANGE 36 EAST, NMPM, LEA COUNTY, NEW MEXICO, IN THE EUMONT GAS POOL.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m., on January 20, 1954, and on February 17, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this 16th day of April, 1954, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises;

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to provisions of Rule 7 (a) of Order No. R-370-A, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal quarter section after notice and hearing by the Commission.

(3) That applicant, Amerada Petroleum Corporation, is the owner of an oil and gas lease in Lea County, New Mexico, the land consisting of other than a legal quarter section, and described as follows, to-wit:

> TOWNSHIP 19 SOUTH, RANGE 36 EAST, NMPM E/2 of W/2 of Section 25

containing 160 acres, more or less.

(4) That applicant, Amerada Petroleum Corporation, has a producing well on the aforesaid lease known as State "T", No. 3, located 1980 feet from the north line and 1980 feet from the west line of Section 25, Township 19 South, Range 36 East, NMPM.

(5) That the aforesaid well was completed and in production prior to January l, 1954, the effective date of Order No. R-370-A, and is located within the limits of the pool heretofore delineated and designated as the Eumont Gas Pool.

(6) That it is impractical to pool applicant's said lease with adjoining acreage in the West half of Section 25, Township 19 South, Range 36 East, NMPM, and that the owners of adjoining acreage in said half section have not objected to the formation of the proposed proration unit of 160 acres.

(7) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the opportunity to recover its just and equitable share of the natural gas in the Eumont Gas Pool.

(8) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste, will protect correlative rights, and is necessary to prevent confiscation of applicant's property.

IT IS THEREFORE ORDERED:

(1) That the application of Amerada Petroleum Corporation, for approval of an unorthodox proration unit consisting of the following described acreage

TOWNSHIP 19 SOUTH, RANGE 36 EAST, NMPM E/2 of W/2 of Section 25

be and the same is hereby approved, and a proration unit consisting of aforesaid acreage is hereby created.

(2) That applicant's well, State "T", No. 3, located in the SE/4 NW/4 of Section 25, Township 19 South, Range 36 East, NMPM, shall be granted an allowable from January 1, 1954 in the proportion that the above described 160 acre unit bears to the standard or orthodox proration unit for said pool, all until further order of the Commission.
