Gentlemen:

Reference is made to the attached notification from ARCO Oil and Gas Company dated September 18, 1992 and received by Hartman September 25, 1992, regarding ARCO's application for an unorthodox location and simultaneous dedication of the above-referenced well. The Barber Gas Com No. 3 (currently known as the B. J. Barber No. 18) well, to be recompleted from the Monument Paddock to the Eumont (Gas) pool, is located 1650' FNL and 330' FEL of Section 7, T-20-S, R-37-E and would be simultaneously dedicated along with ARCO's Barber Gas Com Nos. 1 and 2 wells to the existing 320-acre non-standard Eumont (Gas) proration unit consisting of the E/2E/2 of Section 7 and the W/2W/2 of Section 8, T-20-S, R-37-E, Lea County, New Mexico.

In light of the fact that ARCO's proposed recompletion does not directly offset us and we are not being encroached upon, we do not feel it is appropriate for us to object to ARCO's administrative request for a location consisting of 1650' FNL and 330' FEL of Section 7, T-20-S, R-37-E.

Dear Mr. LeMay:

ARCO Oil and Gas Company respectfully requested, by application to your office on 9/18/92, administrative approval for an unorthodox Eumont gas well location for the Barber Gas Com #3 well (currently known as the B. J. Barber #18 and to be renamed after recompletion) located 1650' FNL, 330' FEL, Section 7, T-20S, R-37E in Lea County, New Mexico. At the same time, ARCO requested simultaneous dedication of the Eumont gas production from the Barber Gas Com Wells #1 and #2 with the Eumont gas production from the Barber Gas Com #3 well.

ARCO Oil and Gas Company notified the offset operators of that application by sending a copy of the application package, along with Waiver to Objection forms, by certified mail. Attached with this follow-up letter are copies of the certified mail receipts sent to all offset operators, showing that they have all received a copy of this application and have had more than 21 days to respond to either ARCO or the NMOCD. 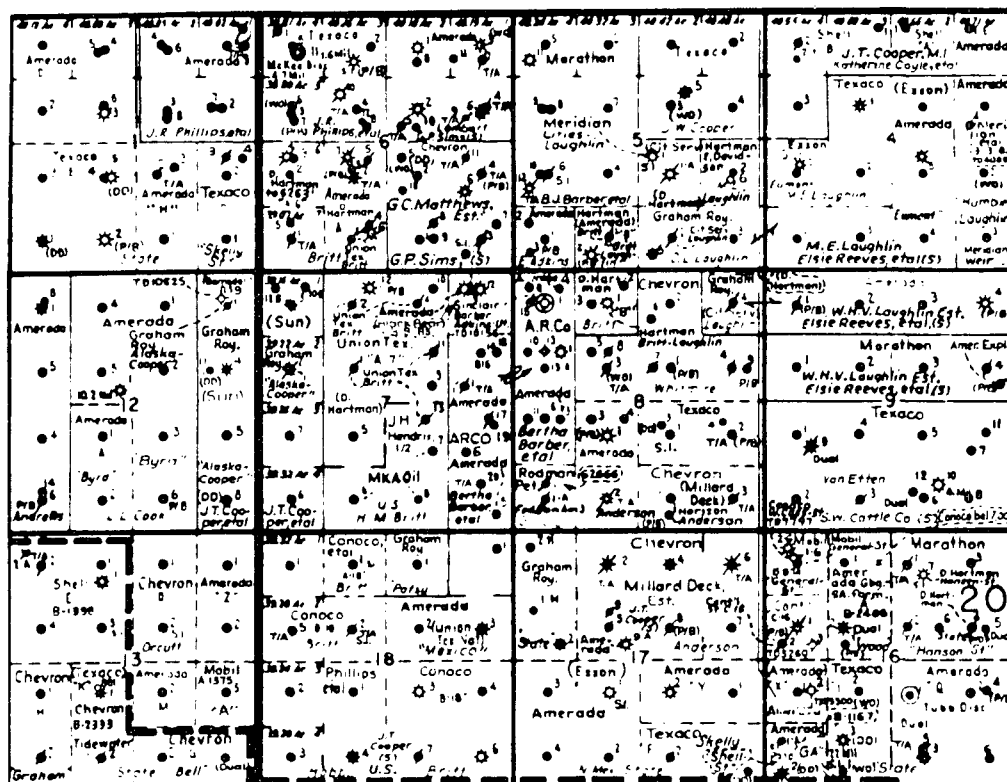


