This is a request for administrative approval to revise the location footages for NSL-4988-B for the Randleman #1N in the Blanco Mesaverde and Basin Dakota pools.

Burlington Resources still plans on drilling and completing the subject well as a Mesaverde / Dakota commingle well. The footages were revised to accommodate the surface owner request to stay off the property line and was adjusted approximately 35' to the west of the previous footage of 690' FNL & 2580' FWL, Sec. 13, T31N, R11W. No other changes were made to the previously submitted NSL application of which NSL-4988-B was approved. This change makes the encroachment approximately 35' less than it previously was and as you mentioned, no further notification will be needed.

When I visited with you this afternoon you gave me instruction on what was needed to adjust the NSL. You also gave verbal approval to drill the subject well as long as we received the revised NSL approval before we first delivered the well.
