## Administrative Order NSL-5795

**Re: Hamner Well No. 2M**  
**API No. 30-045-33995**  
**Unit E, Section 28-29N-9W**  
**San Juan County**

Dear Ms Clugston:

Reference is made to the following:

(a) your application (**administrative application reference No. pKVR08-03632683**) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on February 5, 2008, and

(b) the Division's records pertinent to this request.

ConocoPhillips Company (ConocoPhillips) has requested to produce the above-referenced well at an unorthodox Basin-Dakota and Blanco-Mesaverde gas well location, 1695 feet from the North line and 636 feet from the West line (Unit E) of Section 28, Township 29 North, Range 9 West, N.M.P.M., in San Juan County, New Mexico. The W/2 of irregular Section 28 will be dedicated to this well in order to form a standard 320-acre, more or less, spacing unit in the Basin-Dakota Gas Pool (71599), and the Blanco-Mesa Verde Gas Pool (72319). Spacing in the Basin-Dakota Gas Pool is governed by Rules II.A and II.C of the Special Rules and Regulations for the Basin-Dakota Gas Pool, as most recently amended by Order No. R-10987-B(2), which generally provide for 320-acre units, with wells located at least 660 feet from a unit outer boundary. Spacing in the Blanco-Mesaverde Gas Pool is governed by Rules I.A and I.C of the Special Rules and Regulations for the Blanco-Mesaverde Gas Pool, as amended by Order No. R-10987-A(1), effective December 2, 2002, which generally provide for 320-acre units, with wells located at least 660 feet from a unit outer boundary. This location is less than 660 feet from the western unit boundary.



Your application has been duly filed under the provisions of Division Rules 104.F and 1210.A(2).

It is our understanding that you are seeking this location due to topographic reasons.


It is also understood that you have given due notice of this application to all operators or owners who are "affected persons," as defined in Rule 1210.A(2), in all adjoining units towards which the proposed location encroaches.


Pursuant to the authority conferred by Division Rule 104.F(2), the above-described unorthodox location is hereby approved.
