Re: Application of Texland Petroleum-Hobbs, LLC, for administrative approval of an Unorthodox well location for its Bowers A Federal #41, to be drilled to the Blinebry formation at a surface location 1294 feet from the South line and 533 feet from the East line of Sec. 30, Township 18 South, Range 38 East, N.M.P.M., Lea County, New Mexico.

Dear Mr. Fesmire:

Texland Petroleum-Hobbs, LLC ("Texland") hereby seeks administrative approval pursuant to the provisions of Division Rule 104 F (2)-(4), of an unorthodox well location as a Hobbs Blinebry for its Bowers A Federal #41 located 1294 feet from the South line and 533 feet from the East line of Section 30 (Unit P), Township 18 South, Range 38 East, N.M.P.M., Lea County, New Mexico.

This proposed location in the Blinebry formation is unorthodox because it is governed by state wide rules which provides for wells on 40-acre spacing units to be located 330 feet from any boundary of the spacing unit. The proposed unorthodox well location is at 127 feet from the northern boundary of the proposed spacing unit. A standard 40-acre spacing unit and proration unit comprised of the SE/4 SE/4 of Section 30 will be dedicated to the well.

A non-standard location is required by geologic conditions: as shown on the attached **Exhibit "A"**. Geologic mapping, supported by 3D seismic data, shows the abrupt termination of the Blinebry reservoir to the west and south. By drilling the well at the proposed location the potential for the recovery of economic oil and gas is greatly enhanced.


Exhibit "B" is the C-102 filed for the well that shows the surveyed location of the well.

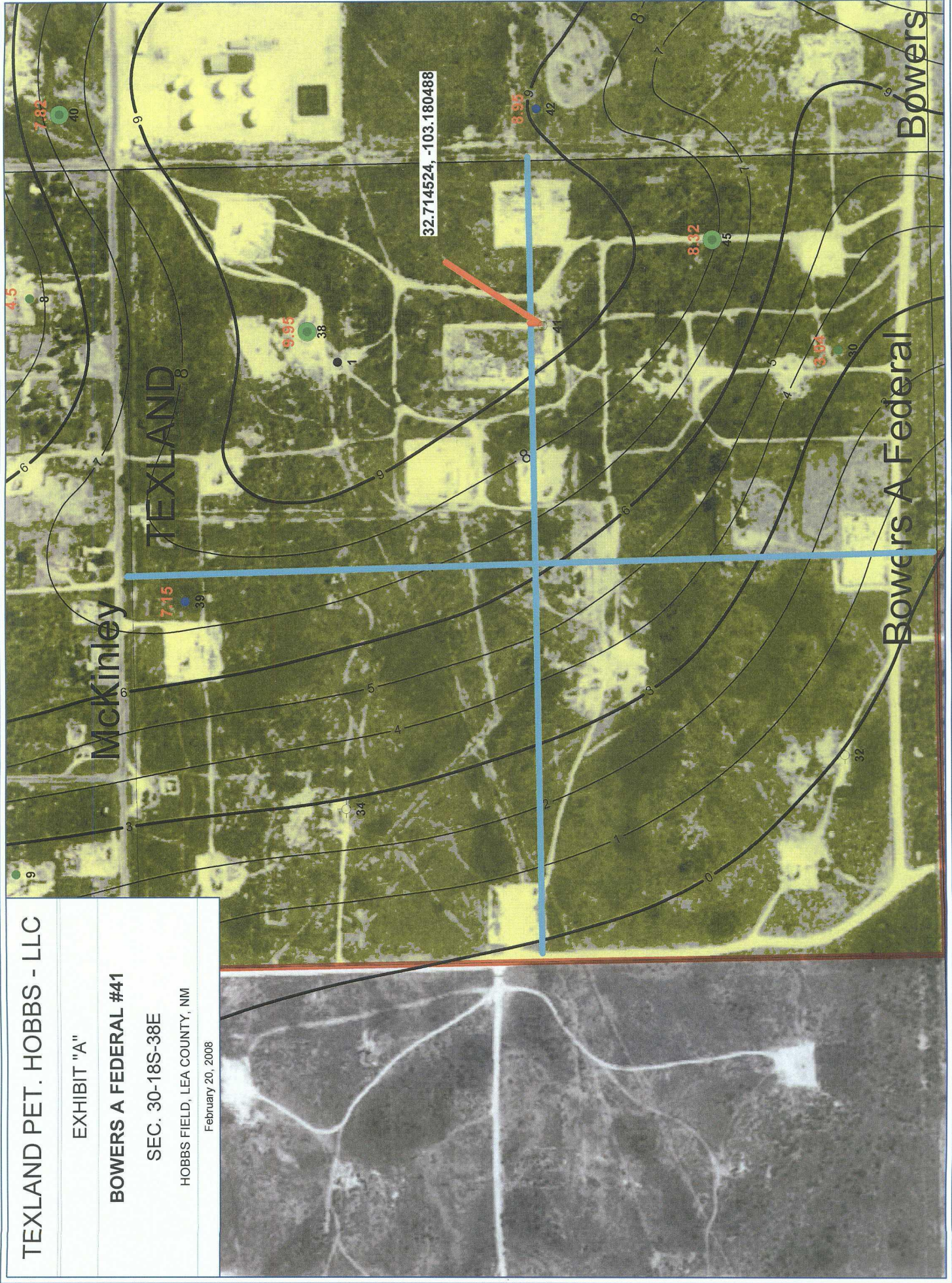

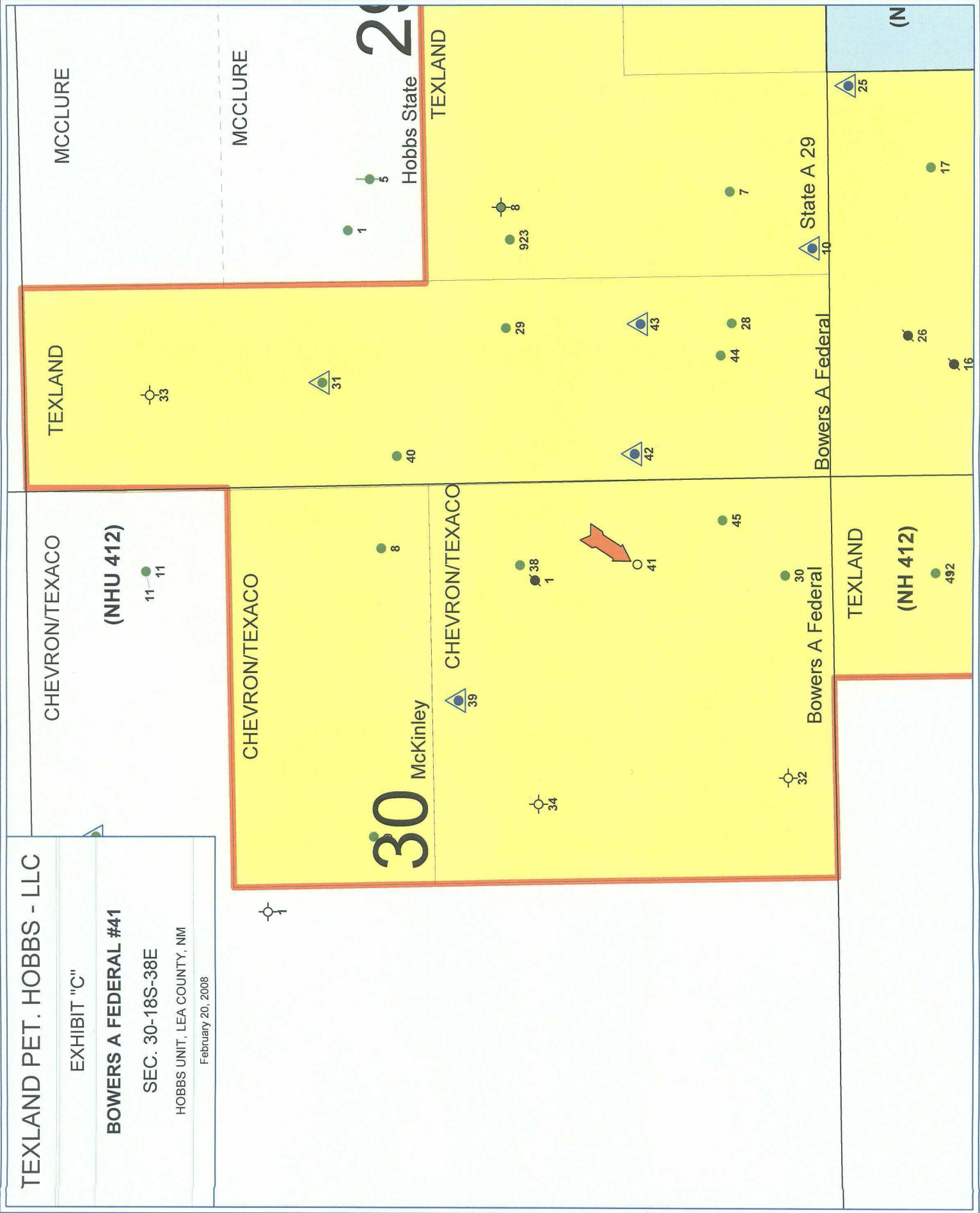
