Dear Mr. Wheeler:

Reference is made to your recent application for an amendment to Division Order No. DHC-3043 dated September 3, 2002, which order authorized the downhole commingling of Skaggs-Drinkard and West Warren-Abo Pool production within the Fred Turner Jr. "B" Well No. 2. It is our understanding that two new pools, the West Nadine Paddock-Blinebry and West Nadine-Tubb Pools are now proposed to be added as commingled zones in the wellbore.

It appearing that the subject well qualifies for approval for such amendment pursuant to the provisions of Rule 303.C., and that reservoir damage or waste will not result from such downhole commingling, and correlative rights will not be violated thereby, you are hereby authorized to commingle the production as described above and any Division Order which authorized the dual completion and required separation of the zones is hereby placed in abeyance.

In accordance with the provisions of Rule 303.C.(1), each of the commingled oil pools shall be allowed to produce up to the top oil allowable and top casing head gas allowable applicable for that pool.

Assignment of allowable to the well and allocation of production from the well shall be on the following basis unless modified with permission of the Hobbs District Office and copied to this office:

Undesignated West Nadine Paddock-Blinebry Pool	Oil-75%	Gas-50%
Undesignated West Nadine-Tubb Pool	Oil-14%	Gas-9%
Undesignated Skaggs-Drinkard Pool	Oil-3%	Gas-32%
West Warren-Abo Pool	Oil-8%	Gas-9%

REMARKS: The operator shall notify the Hobbs District Office of the Division upon implementation of commingling operations.

Pursuant to Rule 303.C.(2), the commingling authority granted herein may be rescinded by the Division Director if conservation is not being best served by such commingling.
