Dear Ms. Bradfield:

The Division received your application requesting approval of an unorthodox coal gas well location for the subject well on Tuesday, January 12, 1994. The form C-102, attached to said filing, contains information requiring further explanation before this application can be processed.

I understand that Section 11 is irregular and contains only 262.28 acres, more or less. The subject C-102 filed with the application has outlined two spacing and proration units, the larger of which contains 262.28 acres and is for the Basin-Fruitland Coal Gas Pool, the smaller representing acreage dedicated to the Aztec Pictured Cliffs Pool, encompasses an area containing 222.28 acres, more or less, and can be described as comprising Lots 1 through 4, the SE/4 SW/4 and the S/2 SE/4 of said Section 11. The "dedicated acreage" box in the upper right shows this small proration unit as containing only 197.08 acres, more or less.

Our well files contain two plats showing the dedicated acreage for the Aztec Pictured Cliffs Pool to the subject well, dated March 28, 1955 and May 17, 1955. The older one (March) shows only 131.63 acres, to be dedicated while the other dated two months later shows 197.08, or Lots 1, 2 and 3, the SE/4 SW/4, and the S/2 SE/4, to be the proper Pictured Cliffs spacing unit.

Which is the correct Pictured Cliffs spacing unit for this well and what is the Division order authorizing its unorthodox size and shape?

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a. m. on May 18, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this 14th. day of July, 1955, the Commission, a quorum being present, having considered the record and the testimony adduced and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to the provisions of Rule 6 (a) of the Special Rules and Regulations for the Aztec-Pictured Cliffs Gas Pool of Order No. R-565, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal quarter section after notice and hearing by the Commission.

(3) That it is advisable to establish the size of the drilling and proration units in the fractional sections on the north border of Township 28 North, Range 10 West and Township 28 North, Range 9 West, that are within the horizontal boundaries of the Aztec-Pictured Cliffs Gas Pool as follows:

- (a) TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM
E/2 Section 10
W/2 W/2 of Section 11

containing 195.08 acres more or less.

- (b) TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM
E 3/4 of Section 11
containing 197.08 acres more or less

- (c) TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM
W 3/4 of Section 12
containing 202.82 acres more or less


