The area is immediately East of the tank and was approximately 2' wide by 50' in length. A truckload of soil was taken to Gandy Marley Commercial Land Farms. A soil samples were taken underlying the spill and all were less than 1000 ppm chlorides. Soil analysis was done by Cardinal Laboratories in Hobbs, see attached analytical Results dated 4/8/08. 250
