Reference is made to the following:

(a) your application (*administrative application reference No. pKVR0813030093*)for a non-standard well location for the subject well that was submitted to the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on May 8, 2008, and

(b) the Division's records pertinent to this request.

COG Operating LLC (COG) has requested authority to drill and complete its MC Federal Well No. 34 at an unorthodox Maljamar; Yeso West oil well location, 1530 feet from the South line and 990 feet from the East line (Unit I) of Section 21, Township 17 South Range 32 East, N.M.P.M., in Lea County, New Mexico. The NE/4 SE/4 of Section 21 will be dedicated to this well in order to form a standard 40-acre oil spacing unit in the Maljamar; Yeso West Pool (44500). The pool is governed by statewide Rule 104.B (1), which provides for 40-acre units, with well located at least 330 feet from a unit outer boundary. The requested location is less than 330 feet from the unit boundary due to pipeline constrictions.

Pursuant to the authority granted under the provisions of Division Rule 104 F(2), the above-described unorthodox Maljamar. Yeso West oil well location within the abovedescribed 40-acre standard oil spacing for the proposed MC Federal Well No. 34 is hereby approved.

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
