Tank, the lease operator noticed a leak had developed in the seam of the tank and water was discharging onto the ground area within the firewall. Afterwards, all fluids were transferred from the storage tank into an empty oil tank. It was estimated 40 bbls. of produced water was released and 30 bbls were recovered.		
Describe Area Affected and Cleanup Action Taken.* 41'x87' area contained inside firewall. Picked up fluid with vacuum truck and emptied tank. Cleaned up area inside firewall.

This office is in receipt of your C-141 on the produced water release, at this facility. As presented, the Initial/Final C-141 cannot be approved. It is accepted for record.

Releases will be addressed in accordance with a **remediation plan** submitted to and approved by the division or with an abatement plan submitted in accordance with Section 19 of 19.15.1 NMAC."


Remediation requirements may be subject to other federal, state and local laws or regulations.
