XTO Energy Inc. (XTO) hereby requests administrative approval for an unorthodox location for the above referenced well. Attached for your reference are the following exhibits:

1. Well location plat (NMOCD Form C-102)
2. Topographic Map
3. Aerial Photograph
4. Dakota & Gallup Ownership Map
5. Dakota & Gallup Production Map

At the proposed location of 2,480' FSL and 660' FWL, the above captioned well is at a non-standard location to the north by 500' for the Dakota formation and 170' for the Gallup formation. The well was placed at this location due to the surface at a standard location to the south being used for agriculture with irrigation as is depicted in the aerial photograph enclosed. The Dakota formation is spaced on a 320-acre S/2 lay-down unit and the Gallup formation is spaced on an 80-acre stand-up unit.

The non-standard location will encroach on XTO's acreage to the north. XTO owns 100% of the offsetting operating rights in the Dakota and Gallup formations, so no offset owner notice is required.

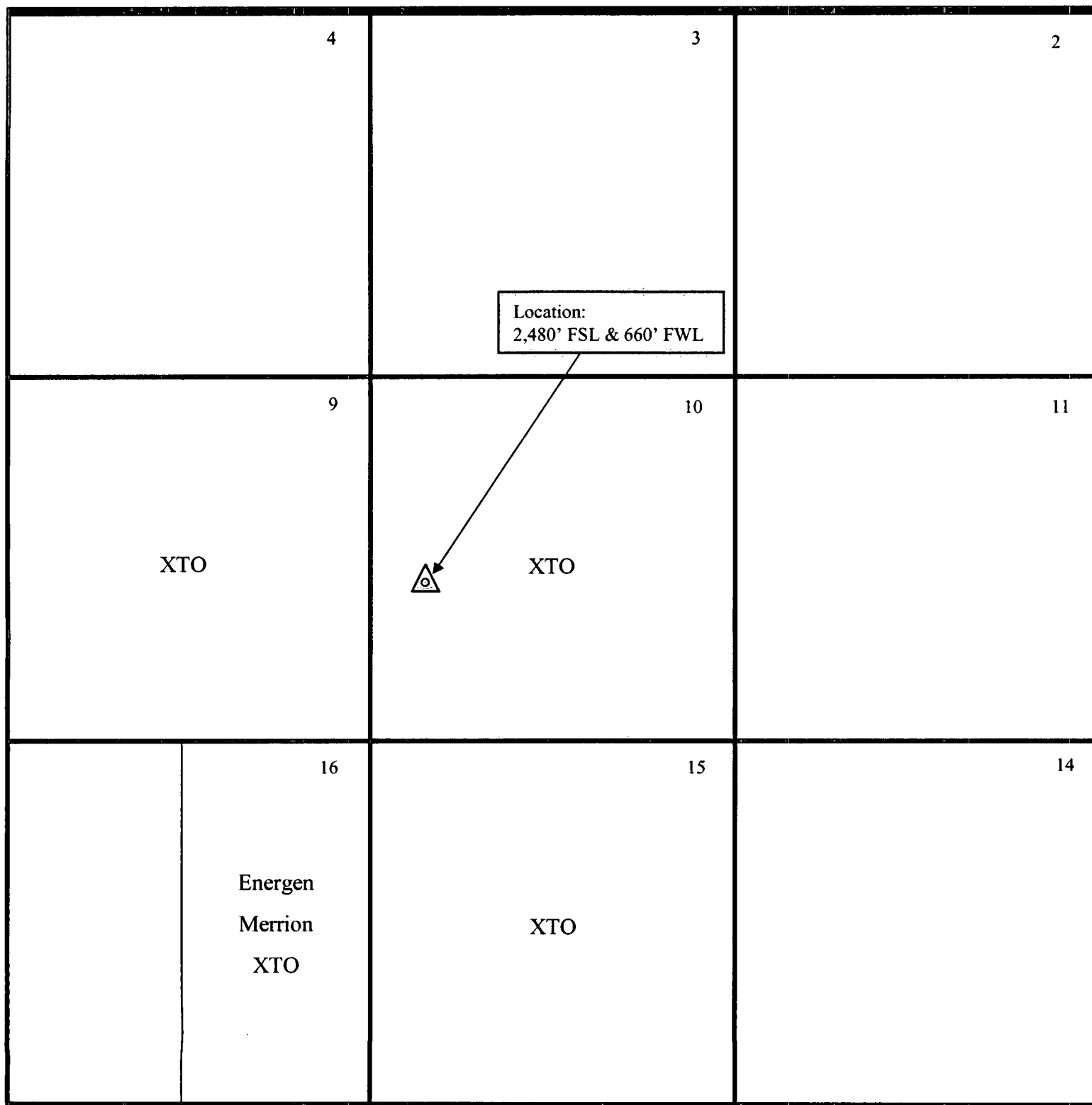
SECTION PLAT OF 9 SQUARE MILES

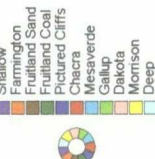
