Weatherford International, Inc. has applied for the renewal of OCD Discharge Permit Number GW-075 for its former Hobbs Fishing and Rental Services facility located in the NE/4 of the SW/4 of Section 20 Township 18S Range 38 East, at 3000 West County Road, Hobbs, Lea County, NM. The facility will be operating as Weatherford Cementation. ②

The facility stores and sells cementation stabilizer baskets. The facility generates solid waste from its shipping materials (cardboard, plastic wrap, and pallets). The facility also generates less than 10 gallons per year of paint related waste recovered through the aerosol can crushing of spray paint cans. The paint waste drum is stored in OCD approved containment. All wastes generated at the facility are sent off site for disposal at NMOCD approved disposal facilities. ③ ④

Groundwater most likely to be affected by a spill, release, or accidental discharge is at a depth of approximately averaging 100 to 150 feet, with a total dissolved solids concentration of approximately 1300 mg/l. ⑤
