The Harvey A 3N is a Blanco Mesaverde, Basin Dakota and Otero Chacra New Drill. A cased hole neutron log will be run prior to completion to identify the Blanco Mesaverde, Basin Dakota and Otero Chacra zones. If the Blanco Mesaverde, Basin Dakota and Otero Chacra horizons can be isolated, a separator test will be performed and the allocation will be assigned with results using the subtraction method applied to the rate. In the event that the Blanco Mesaverde, Basin Dakota and Otero Chacra can not be tested separately, a volumetric calculation will be performed to determine the allocation percentages between the Blanco Mesaverde, Basin Dakota and Otero Chacra. All documentation will be submitted to the Aztec NMOCD office.
