Yates Petroleum Corporation in accordance with Division General Rule 19 NMAC 15.C.104.F applies to the New Mexico Oil Conservation Division for approval of an unorthodox well location for any and all oil or gas production from surface to the base of the Siluro-devonian formation for its proposed Houston BDH State Com. #2 to be drilled at an unorthodox gas well location of 1,550 feet from the North line and 2,500 feet from the West line (Unit F) of Section 31, Township 9 South, Range 27 East, NMPM, Chaves County, New Mexico and to be dedicated to a 320 acre spacing unit consisting of the N/2 of Section 31, and in support states:

- Yates Petroleum Corporation (Yates) is the proposed operator of subject well and is a working interest owner in the N/2 of Section 31. (See Exhibit # 1 and #4)
- Yates proposes to drill its Houston BDH State Com. #2 at an unorthodox oil and gas well location of 1,550 feet from the North line and 2,500 feet from the West line (Unit F) of Section 31, Township 9 South, Range 27 East, NMPM, Chaves County, New Mexico. (See Exhibit # 2)
- 3) The subject well is to be drilled at an unorthodox location in an attempt to drill the best geological location to determine the potential to produce gas from the formations that require a 320 acre spacing unit. (See Exhibit # 3)
- 4) In the event the Siluro-devonian is not capable of commercial production in this well, then Yates intends to test all possible oil and gas formations above the Siluro-devonian formation prior to plugging the well. The well location would be

unorthodox for formations that require a 160-acre spacing unit for gas and 40-acre spacing for oil.

- 5) The lease on which the well will be drilled will be communitized with the other lease in the spacing unit to form a 320.12-acre spacing unit dedicated to this well in the N/2 of Sec. 31-T9S-R27E for formations that require a 320 acre spacing unit. For a gas well completed in the NW/4 of Section 31-T9S-R27E requiring 160 acre spacing unit, a 160.12-acre spacing unit would be formed and for oil wells requiring a 40 acre spacing unit a 40-acre spacing unit in the SE/4NW/4 of Sec. 31-T9S-R27E would be formed.
- 6) The proposed location only encroaches to the interior lease lines of Section 31 and the lease that is encroached on to the East is identified on Exhibit #1 and the owners are identified on Exhibit #4. Waivers have been requested from affected persons as defined by 19 NMAC 15.N.1207.A.2 and will be forwarded to the Division if obtained. (See Exhibit #1 and #4)
- 7) Notice of this application was mailed the same date as this application to all affected persons identified in Exhibit #4 as required by the Division's rules by certified mail, return receipt requested and is verified by Exhibit #5.

Wherefore, Yates Petroleum Corporation requests that the Division approve this matter administratively.




