

Lightning stuck produced water tank, causing release. Vacuum truck called and backhoe crew called.

An approximate area of 20' X 20'. All within bermed tank battery. Vacuum truck picked up remaining produced water; impacted soils were excavated and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. **Depth to Ground Water: <50' (approx. 25')**, Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20.
