Continental Oil Company Application for 200 acre NSP Unit for its Meyer B-27 No. 1 Well in Section 27, T2OS, R37E, Eumont pool, Lea County, New Mexico.

Gentlemen:

Continental Oil Company respectfully request administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the <u>Bumont Gas Pool</u> of Order No. R-520 for the formation of a 160-acre non-standard gas provation unit for its Meyer B-27 No. 1 well located 1980 feet from North Line and 660 feet from the West line of Section 27, T20S, R37E, Lea County, New Mexico in the Eumont gas pool.

The unit is proposed to consist of the 160 acres comprising the Northwest Quarter of Section 27, T20S, R37E.

In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5 (b) in all respects as follows:

- 5. Copies of this application have been furnished this date by registered mail to all offset operators and all operators within 1,500 feet of said well, as required by the provisions of said Rule 5 (b).



Reference is made to the following: (i) your application submitted to the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on August 23, 2006 (*administrative application reference No. pMES0-625528411*); and (ii) the Division's records in Hobbs and Santa Fe, including the file on Division Administrative Order NSP-282: all concerning Plantation Operating, L.L.C.'s ("Plantation") plans for additional development of the Eumont Gas Pool (76480) within the existing non-standard 160-acre gas spacing unit comprising the NW/4 of Section 27, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.

Your application has been duly filed under the provisions of the "Special Pool Rules for the Eumont Gas Pool," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001.

By Division Administrative Order NSP-282, dated July 11, 1956, this 160-acre nonstandard gas spacing unit was initially established for Plantation's Meyer "B-27" Well No. 1 (*API No. 30-025-06271*), located at a standard gas well location 1980 feet from the North line and 660 feet from the West line (Unit E) of Section 27.

It is the Division's understanding that Plantation now intends to drill its proposed Meyer "B-27" Well No. 2 at a standard infill gas well location 960 feet from the North line and 1980 feet from the West line (Unit C) of Section 27.

By the authority granted me under the provisions of Rules 4 (B) and (D) of the special rules governing the Eumont Gas Pool, Plantation is hereby authorized to simultaneously dedicate Eumont gas production to the above described 160-acre non-standard gas spacing unit from both its existing Meyer "B-27" Well No. 1 and proposed Meyer "B-27" Well No. 2. Furthermore, all provisions applicable to the subject unit in Division Administrative Order NSP-282 shall remain in full force and affect until further notice.
