Re: Application for 40 acre non-standard gas proration unit for Texas Pacific Coal and Oil Company's Sarkeys No. 1 and No. 2 located in the W/2 of NW/4 Section 25, Township 21 South, Range 37 East, Lea County, New Mexico.

## Gentlemen:

Taxas Pacific Coal and Oil Company respectfully requests administrative approval under provisions of Rule 5 (c) of Order No. 1670 for the formation of an 40 acre non-standard gas proration unit for its Sarkey, Well No. 1 located 1980 feet from the north line and 660 feet from the west line and its Sarkey, Well No. 2 located 660 feet from the north line and 660 feet from the west line, Section 25, Township 21 South, Range 37 East, Lea County, New Mexico in the Blinebry Gas Pool. These two wells were reclassified by order of the New Mexico Oil Conservation Commission effective January 1, 1963 from Blinebry Oil wells to Hlinebry gas wells. In support of this request we state the following:

- 1. The proposed non-standard 40 acre unit for Well No. 1 consists of the SW/4 of the NW/4 of Section 25, Township 21 South, Range 37 East and the proposed non-standard 40 acre unit for Well No. 2 consists of NW/4 of the NW/4 of Section 25, Township 21 South, Range 37 East.
- 2. Each unit lies wholly within a single governmental quarter section.

- 3. The entire non-standard unit for each well may reasonably be presumed to be productive of gas.
- 4. The length or width of either unit does not exceed 2640 feet.
- 5. Copies of this application have been submitted to all operators as required under Rule 5 (c) subparagraph 6.

In view of these facts, it is requested that the Commission enter an order approving the non-standard gas proration unit for Texas Pacific Coal and Oil Company, Sarkey Well No. 1 and Sarkey Well No. 2, as described above.
