Gentlemen:

Our State Land "15" Well No. 2 by authorization of NSP-500 is assigned an 80-acre Blinbry Gas Pool proration unit. The unit consists of the S/2 SW/4 Section 16, T 21 S, R 37 E. The well is located 660 feet from south line and 1980 feet from west line of Section 16.

Due to our recent completion of the west offset (State Land "15" No. 1) in the Blinbry Oil Pool, we hereby request reduction of the present 80 acre gas proration unit to 40 acres, namely, SE/4 SW/4 Section 16-T21S-R37E.

A plat showing subject well, lease, and offset development is attached. Also attached is Form C-128 for the amended acreage assignment.

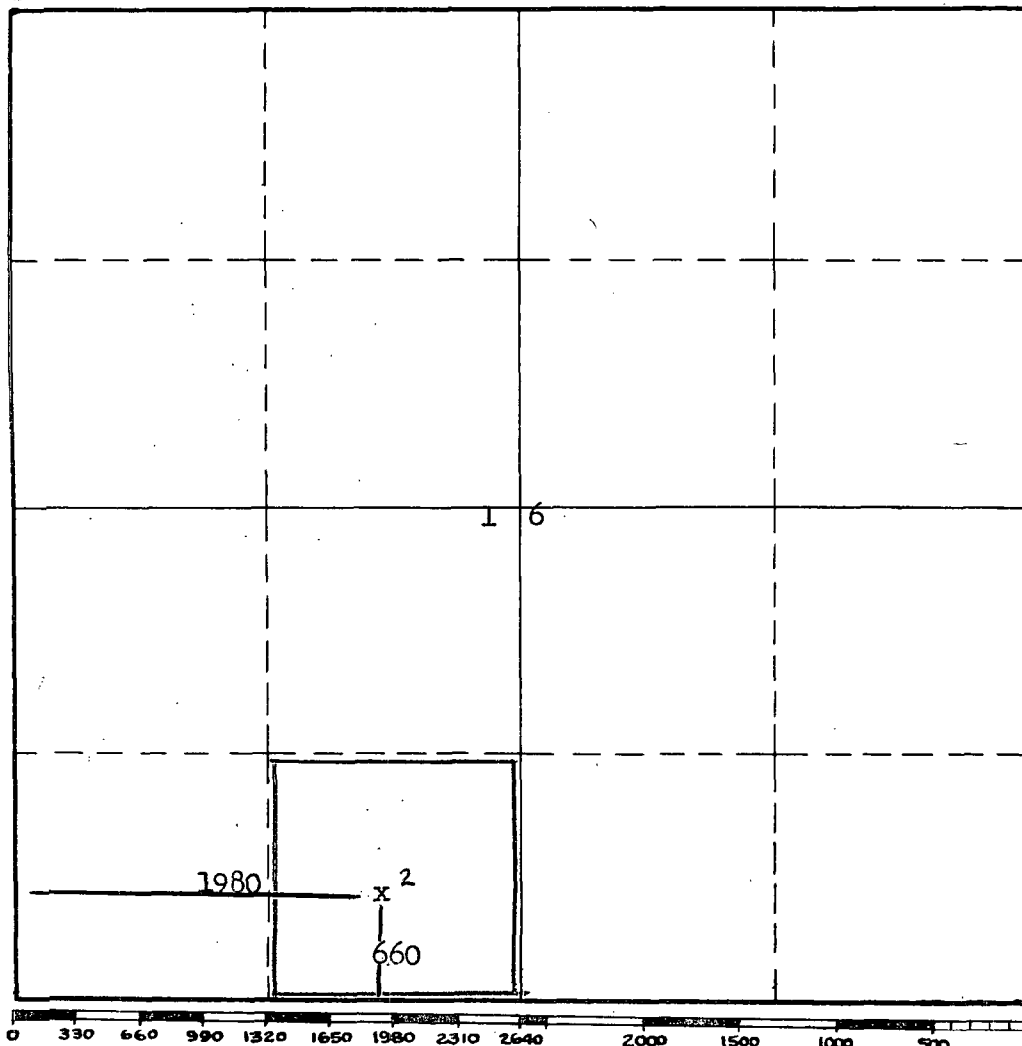
