A non-standard 40 acre Blinebry gas unit is requested for the Weatherly "E" No. 1. This well is located in Unit "G" and is the 40 acres requested for the well.

NSP-728

A non-Standard 120 acre Blinebry gas unit is requested for the Weatherly No. 3. This well is located in Unit "C". The 120 acres will be comprised of Units "C", "D" and "E".

The remaining 80 acres in the Weatherly lease, being Unit "C" and "F" will be allocated to the Weatherly Nos. 4 and 6 for Blinebry oil units.


