The New Mexico Oil Conservation Division (OCD) has received Plains' report and request for soil closure of the above-referenced site (dated, December, 2008). The above-referenced report, submitted in partial fulfillment of 19.15.30.19 NMAC (Part 30.19, formally, Rule 19.K), indicates that Plains has partially met the requirements of 19.15.30.9 NMAC for this site. Therefore, the OCD hereby conditionally approves the Soil Closure Report for the Hugh Gathering (East Side NMSR18) Release Site and no further soil remediation is required for this site.
