Re: Application for Administrative  
 Approval of Non-Standard Spacing  
 Unit in Jalmat Gas Pool, Lea  
 County, New Mexico

Gentlemen:

We propose to re-enter a plugged well now called the Burleson & Huff No. 1 Lanehart well situated 660 feet from the south and west lines of Section 21, T-25-S, R-37-E, N. M. P. M., Lea County, New Mexico and test the Yates formation at a depth of about 2600 feet. Such well is situated within the boundary of the Jalmat Gas Pool. We own leases covering the S/2 of SW/4 and NW/4 of SW/4 of said Section 21 down to a depth of 3000 feet, which is below the base of the Yates formation.

We hereby make application for approval by the Commission of a non-standard spacing unit in the Jalmat Gas Pool consisting of the S/2 of SW/4 and NW/4 of SW/4 of said Section 21 for our No. 1 Lanehart well and request that under Section D, Sub-Section II of Rule 104 of the Oil Conservation Commission Rules and Regulations, the Secretary-Director of the Commission grant administrative approval without notice and hearing designating such tract of land as the spacing unit for the production of gas from our said No. 1 Lanehart well.

Our request is made due to the fact that the only acreage we have under lease in said Section 21 surrounding the aforementioned No. 1 Lanehart well is the S/2 of SW/4 and NW/4 of SW/4 of said Section 21, and we wish to designate such acreage as the spacing unit for gas production.

We have mailed copies of this Application and attached plat by certified mail with return receipt requested to all of the off-setting Operators to the proposed spacing unit and all other Operators of oil and gas leases situated in Section 21, notifying them of our application. All such Operators have been requested to sign a written consent in the form of a Waiver to our proposed spacing unit. The off-setting Operators, except Burleson & Huff, the applicants herein, are as follows: Union Texas Petroleum, Tenneco Oil Company, Aztec Gas Systems, Thornton Petroleum Corporation, Humble Oil & Refining Company and Reserve Oil & Gas Company.


A copy of a plat on which the No. 1 Lanehart well is located and the proposed spacing unit is outlined in red is attached.
