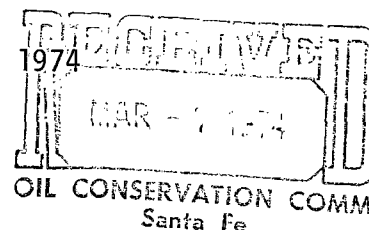

Gentlemen:

Mobil Oil Corporation respectfully requests administrative approval of a non-standard gas proration unit for the subject well. This well is located in Lot 7, Unit G, 1600 ft from the north line and 2100 ft from the east line of Sec. 6, T-21-S, R-27-E, Eddy County, New Mexico. This proposed non-standard unit is necessitated by a variation in a legal subdivision of the U.S. Public Surveys. It will comprise Lots 1, 2, 3, 4, 5, 6, 7 & 8 of said Sec. 6, and it will contain 276.32 acres of land more or less.

In support of this request the following items are being submitted in duplicate:

1. NMOCC Form C-102 showing the location of the subject well and the acreage to be assigned to it.
2. Plat showing all of Sec. 6 and the offset lease holders to Mobil's Federal State Com lease. This lease (non-standard unit also) is outlined in yellow and the well is indicated by a red arrow.
3. Address list of offset lease holders.
4. Copy of letter sent to offset lease holders requesting their waivers.

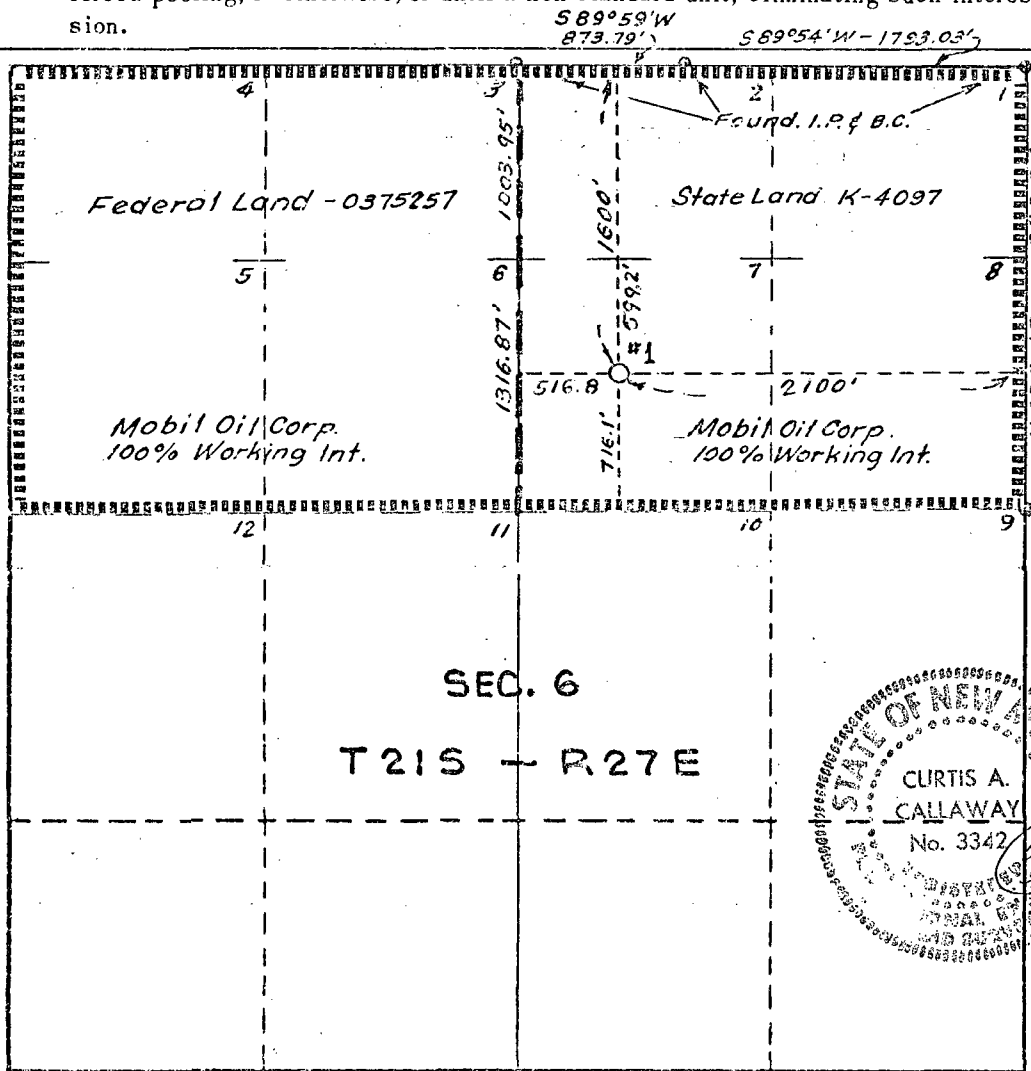
