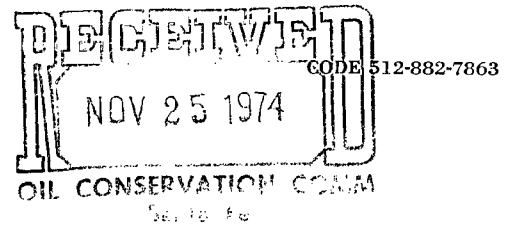

Your Order mistakenly referred to this well as the #1-A Hill Federal.

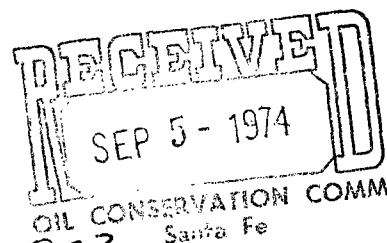

The above well was completed as a shut-in gas well on March 24, 1971. According to R4434, which amended Rules 2 and 3 of R3981-A, each well should be on a 320-acre unit. 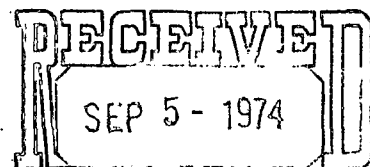

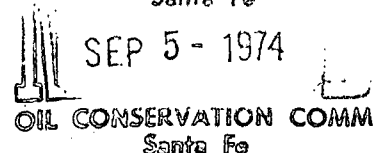
