RE: Soil Sampling Plan for the Thriftway Refinery, 626 County Road 5500, Bloomfield, New Mexico

Dear Mr. Hansen:

On behalf of Thriftway Company (Thriftway), Animas Environmental Services, LLC (AES) is providing this soil sampling plan in response to the November 9, 2009 meeting between the New Mexico Oil Conservation Division (OCD), Thriftway, and AES.

In the November 9, 2009 meeting, OCD and Thriftway agreed that confirmation soil sampling will be conducted upon termination of the active phase of the treatment designed to remove Non-Aqueous Phase Liquid (NAPL) contamination from the most heavily contaminated areas of the property. Until that time, AES/Thriftway are proposing a general soil sampling plan so that the remediation approach can be approved by OCD and work to begin the active NAPL remediation can begin.

In general, the plan for conducting soil confirmation sampling is currently proposed as follows:

- 1) Within 3 months of completing the interim cleanup of NAPL, AES/Thriftway will prepare and submit a detailed work plan for conducting the soil confirmation sampling, which will be based on the preliminary approach outlined in items #2 through #6 below.
- 2) At the end of NAPL removal, Thriftway/AES will conduct the installation of test pits in the actively treated area;
- 3) AES/Thriftway anticipate completing approximately 40-50 test pits to adequately cover the treated area at the same level of detail as for the contaminant delineation work previously conducted;
- 4) During test pit completion, AES will log soils and record volatile soil gas readings using a Photo-Ionization Detector/Organic Vapor Meter (PID/OVM);
- 5) Based on PID/OVM readings, AES/Thriftway will collect approximately one (1) laboratory confirmation sample per ten (10) test pits; and
- 6) Laboratory results will be presented to OCD with a summary letter report documenting the activities and findings of the soil confirmation sampling event.



AES and Thriftway appreciate the opportunity to provide this interim soil sampling plan and anticipate finalizing the arrangements to begin initial operation of the interim NAPL remediation system by the end of 2009.

On behalf of Thriftway Company (Thriftway), Animas Environmental Services, LLC (AES) is providing this soil sampling plan in response to the November 9, 2009 meeting between the New Mexico Oil Conservation Division (OCD), Thriftway, and AES.

In the November 9, 2009 meeting, OCD and Thriftway agreed that confirmation soil sampling will be conducted upon termination of the active phase of the treatment designed to remove Non-Aqueous Phase Liquid (NAPL) contamination from the most heavily contaminated areas of the property. Until that time, AES/Thriftway are proposing a general soil sampling plan so that the remediation approach can be approved by OCD and work to begin the active NAPL remediation can begin.

In general, the plan for conducting soil confirmation sampling is currently proposed as follows:

- 1) Within 3 months of completing the interim cleanup of NAPL, AES/Thriftway will prepare and submit a detailed work plan for conducting the soil confirmation sampling, which will be based on the preliminary approach outlined in items #2 through #6 below.
- 2) At the end of NAPL removal, Thriftway/AES will conduct the installation of test pits in the actively treated area;
- 3) AES/Thriftway anticipate completing approximately 40-50 test pits to adequately cover the treated area at the same level of detail as for the contaminant delineation work previously conducted;
- 4) During test pit completion, AES will log soils and record volatile soil gas readings using a Photo-Ionization Detector/Organic Vapor Meter (PID/OVM);
- 5) Based on PID/OVM readings, AE\$/Thriftway will collect approximately one (1) laboratory confirmation sample per ten (10) test pits; and
- 6) Laboratory results will be presented to OCD with a summary letter report documenting the activities and findings of the soil confirmation sampling event.

Thank you for your response to Thriftway Company's Periodic Progress Report for the above referenced facility.

Thriftway Company continues to have concerns regarding the sampling requirements set out as conditions in your email. As you may be aware, Thriftway Company is, and has for the last several years, been an essentially dormant corporation with no current business activities and, accordingly, no inflow of cash. As a result, Thriftway Company is very mindful of its finite resources and wants to proceed efficiently and devote as much of its finances as possible toward actual hydrocarbon contamination removal at the site. Thriftway Company understands that monitoring is an essential component of remediation to gauge progress at the site. However, we need to discuss with OCD what frequency of sampling will yield truly meaningful data given the breadth and scope of the project.

Accordingly, Thriftway Company requests a meeting with yourself and any other necessary OCD personnel involved with this project to discuss the sampling requirements. Additionally, we believe a site visit would be very beneficial at this time so that OCD can view the progress made to date. Our environmental consultants at Animas Environmental Services would be in attendance to discuss the issues at hand and answer any questions you might have.

RE: Periodic Progress Report Approval for the Thriftway's Thriftway Bloomfield Refinery Release Site (GW-55) 626 County Road 5500, Bloomfield, San Juan County, New Mexico

Dear Mr. Moss:

The New Mexico Oil Conservation Division (OCD) has received the periodic progress report for the above-referenced site, dated October 28, 2009, and has conducted a review of the report. The report substantially meets the requirements of 19.6.2 NMAC. Therefore, the OCD hereby approves the report subject to the following conditions (in addition to the conditions set forth in the CAP approval):

- For the first year of implementing the plan, Thriftway must sample groundwater quarterly and submit a groundwater analytical report to the OCD within 45 days of each sampling event. However, the following parameters may be analyzed on an annual basis: 8260B parameters (not including BTEXN and MTBE), GRO, DRO, MRO, RCRA 8 metals, Calcium, Magnesium, Potassium, Sodium, Bromide, Fluoride, Specific Conductance and Hardness. The remaining parameters must continue to be analyzed on a quarterly basis: listed field parameters, BTEXN, MTBE, Chloride, Sulfate and TDS.
- 2. Thriftway must submit to the OCD for review and approval a soil sampling plan within <u>10 days</u>. The plan may be part of the multi-phase extraction wells installation (e.g., soil samples could be taken with the installation of the wells).

Please be advised that OCD approval of this report does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the owner/operator of responsibility for compliance with any OCD, federal, state, or local laws and/or regulations.

Dear Mr. Jones:

On behalf of Thriftway **Compo**ry (Thriftway), Animas Environmental Services, LLC (AES) is providing an update to the New Mexico Oil Conservation Division (NMOCD) on the progress made toward refinery dismantling and remediation of hydrocarbon contaminated soil and groundwater. Tasks completed since June 2008 are described below.

- 1. In June and July 2009, Tank #17, 18, 19 and 21 were emptied of residual oil and cleaned. As with the tanks cleaned in 2008, all recovered oil and wash water was transported to Western Refinery for recycling. Following cleaning, each tank was inspected by Western Refinery personnel and determined to be satisfactory.
- 2. Between August 19 and 24, 2009, groundwater monitoring and sampling was completed. A monitoring and sampling report is being prepared and will be submitted to the NMOCD by the end of October 2009.
- 3. In September 2009, most of the crude oil and finished product piping was cleaned and removed for scrap. Waste water associated with pipe cleaning was taken to Basin Disposal, and the pipe insulation was disposed of at the Waste Management Landfill on Crouch Mesa.
- 4. A Storm Water Pollution Prevention Plan (SWPPP) for construction activities was prepared to cover site grading and leveling in preparation for installing the multiphase extraction (MPE) wells. The Notice of Intent (NOI) was filed electronically with the United State Environmental Protection Agency (USEPA) Region 6 on September 16, 2009.
- 5. Between September 23 and 25, Phase I and II remediation areas were leveled and graded to facilitate operation of the drilling rig that will be used to install MPE wells.
- 6. On September 29, 2009, an Application to Appropriate Groundwater was submitted to the New Mexico State Engineer for MPE-1 through MPE-19. Applications for additional MPE wells will be submitted at a later date.

Once the installation and operation of the MPE wells is approved by the State Engineer, MPE-1 through MPE-19 will be permitted and will then be installed shortly after.
