Laughlin No. 4, Unit A. The requested non-standard proration is currently assigned to the Amerada Hess Corporation V. Laughlin No. 1, located in Unit D, Sec. 9, T-20-S, R-37-E, Lea County, New Mexico, which was temporarily abandoned April 3, 1975 by order R-442. The V. Laughlin Well No. 1 will be plugged and abandoned when Well No. 4 is changed from a Tubb Oil Zone Well to a Eumont Queen Gas Zone Well.

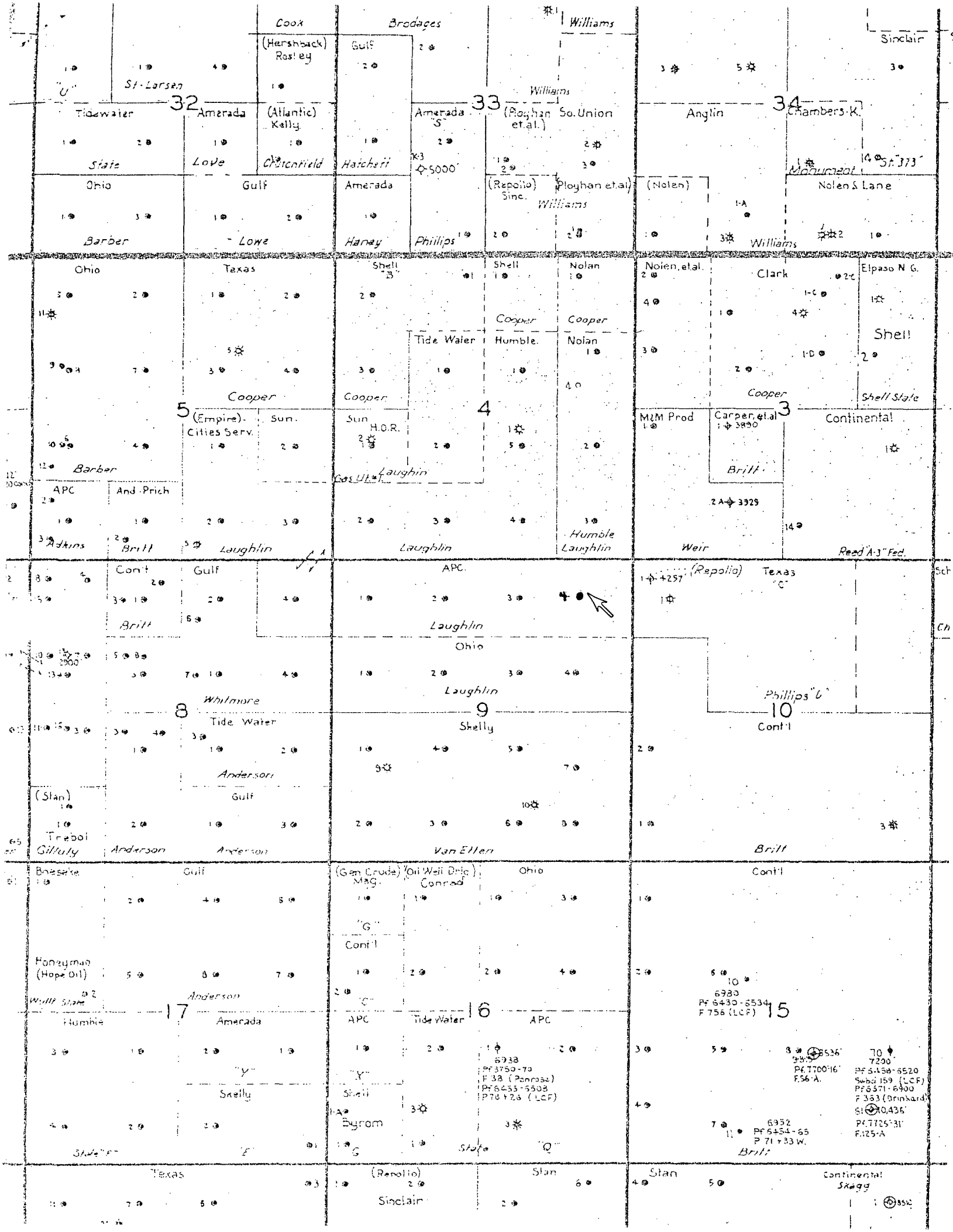
