Apache Corporation ("Apache") respectfully requests to revise the non-standard bottom-hole location of the J G Hare #18 well to **1302' FSL & 1330' FWL (Unit Letter N) of Section 33, Township 21 South, Range 37 East, Lea County, New Mexico**. Current non-standard bottom-hole location (1310' FSL & 1330' FWL, Unit Letter N, of same Section 33) for the J G Hare #18 was approved via Administrative Order No. <u>NSL-6145-A</u>, dated February 18, 2010, covering the Blinebry and Tubb formations.

However, the currently approved non-standard bottom-hole location is closer than 10' to the inner boundaries of the spacing unit in which this well will be dedicated. It appears Section 33 does not make up a true 640 acre section making the measurements off the section line a little skewed. As a result, and in order for the well to remain at least 10' off the spacing unit boundaries, the bottom-hole location must be revised as set forth above in this amendment.

Apache owns 100% leasehold interest as to the Blinebry and Tubb formations in the entire SW/4 of said Section 33-T21S-R37E. Therefore, no other parties will need to be notified of this change.
