Fasken Oil and Ranch, Ltd. operates the Avalon State No. 1 SWD in Eddy County, API No. 30-015-20743, under Administrative Order SWD 1115. This order was made "now in effect" on July 23, 2008 per Mark Fesmire's letter. (Samson had to plug a well and turn in their plugging records before the order was made effective.) Fasken began injection in this well in September 2009, which is a month past the one year permit time. There were a number of issues that caused this delay. First we did the well work in late November 2008. The well would not take water on a vacuum as we had anticipated, and we spent quite a bit of time trying to get the formation to go on vacuum. Next we investigated trying to get power to the well to allow us to put an electric injection pump on location to allow injection. Our investigation proved that the power lines in the area that serve the rancher would not allow us to put an electric pump online as it would cause a "brownout" at the rancher's house. We then ordered a gas powered tri-plex pump that took 3 months to receive and install. After getting the pump in place and bugs ironed out, we began injection.

It was our oversight to not inform you of these issues prior to the one year permit expiration date. However, it is obvious by the narrative above that we have been aggressively trying to get this well online and injecting.

We are requesting your approval to continue our injection into this well. Fasken will re-submit the application should you deem that necessary to clean up the paper trail.
